# KATA PENGANTAR

Penerbitan ini memaparkan statistik suku tahunan produktiviti buruh di Malaysia bagi suku tahun pertama 2022. Konsep produktiviti buruh yang digunakan merujuk kepada nisbah antara nilai ditambah dan input iaitu jam bekerja dan pekerja. Statistik yang diterbitkan adalah berdasarkan saranan daripada *System of National Accounts 2008*, *The United Nations* dan *The Organisation for Economic Co-operation and Development Manual: Measuring Productivity*.

Data suku tahunan yang dibentangkan dalam penerbitan ini bermula dari suku tahun pertama 2018 hingga suku tahun pertama 2022. Anggaran nilai ditambah pada harga malar dinilai pada harga asas 2015 selaras dengan pengasasan semula Statistik Akaun Negara.

Statistik ini disusun mengikut aktiviti ekonomi bagi memenuhi keperluan *Malaysia Productivity Blueprint*. Maklumat yang dihasilkan boleh dijadikan petunjuk utama dalam mengukur produktiviti negara bagi pembentukan, pelaksanaan dan pemantauan polisi serta prestasi ekonomi. Statistik ini juga menjadi rujukan penyelidik, ahli akademik, pihak swasta dan individu.

Terdapat empat bahagian di dalam penerbitan ini. Bahagian pertama memaparkan ringkasan penemuan utama statistik produktiviti buruh. Jadual perangkaan terperinci dipaparkan di bahagian kedua. Mulai penerbitan suku tahun pertama 2022, indeks produktiviti buruh diterbitkan kepada umum sebagai satu komponen baharu penerbitan, iaitu di bahagian ketiga. Sementara itu, aspek teknikal seperti skop dan liputan, konsep dan definisi serta pembolehubah utama yang digunakan disediakan di bahagian keempat bagi memudahkan pengguna memahami statistik yang diterbitkan.

*This publication presents quarterly labour productivity statistics in Malaysia for the first quarter of 2022. The concept of labour productivity used refers to the ratio between value added and input namely hours worked and employment. The statistics published are based on the recommendations of the System of National Accounts 2008, The United Nations and The Organisation for Economic Co-operation and Development Manual: Measuring Productivity.*

*Quarterly data presented in this publication commences from the first quarter of 2018 to the first quarter of 2022. The value added estimates in constant prices are expressed in 2015 prices in tandem with the rebasing of National Accounts Statistics.*

*The information is produced by economic activity to fulfil the requirements of the Malaysia Productivity Blueprint. The statistics provided can be used as an important indicator in measuring national productivity for the formulation, implementation and monitoring policy as well as performance of the economy. The statistics also serve as an essential reference to analysts, economists, academics, private sectors and individuals.*

*This publication is divided into four sections. The first section presents the summary of findings of the statistics on labour productivity. The second section of this publication provides detailed statistical tables. Starting first quarter 2022, labour productivity indices will be included as a new component to the publication that is in section three. Meanwhile, technical aspects such as scope and coverage, concepts and definitions as well as key variables used are described in the fourth section to facilitate users in better understanding of the statistics.*











# PRESTASI PRODUKTIVITI BURUH SUKU PERTAMA 2022




Pada suku pertama 2022, produktiviti buruh Malaysia yang diukur sebagai nilai ditambah per jam bekerja meningkat pada kadar marginal 0.3 peratus (ST4 2021: 1.3%) seperti yang digambarkan dalam **Carta 1**. Pada suku ini, nilai ditambah berkembang 5.0 peratus (ST4 2021: 3.6%) manakala jam bekerja meningkat 4.6 peratus (ST4 2021: 2.3%).

Sementara itu, produktiviti buruh yang digambarkan sebagai nilai ditambah per pekerja meningkat 2.7 peratus (ST4 2021: 1.7%) sementara pekerja meningkat 2.2 peratus (ST4 2021: 1.8%) seperti yang ditunjukkan dalam **Carta 2**.

Produktiviti buruh bagi nilai ditambah per jam bekerja pada suku ini adalah RM40.3 per jam (ST4 2021: RM42.3 per jam) manakala nilai ditambah per pekerja adalah RM23,129 (ST4 2021: RM24,047 per pekerja).



## PERTANIAN


Bagi sektor Pertanian, produktiviti buruh per jam bekerja pada suku ini turun marginal 0.2 peratus berbanding pertumbuhan positif 1.7 peratus suku sebelumnya. Nilai ditambah bagi sektor ini meningkat 0.2 peratus (ST4 2021: 2.8%) sementara jumlah jam bekerja meningkat 0.4 peratus (ST4 2021: 1.1%) seperti di **Paparan 1**.

Produktiviti buruh mengikut nilai ditambah per pekerja merekodkan pertumbuhan yang lebih perlahan sebanyak 1.0 peratus (ST4 2021: 2.9%). Di samping itu, pekerja kekal dalam trend menurun sebanyak 0.8 peratus berbanding negatif 0.1 peratus suku sebelumnya.

Pada ST1 2022, nilai ditambah per jam bekerja bagi sektor ini adalah RM22.9 (ST4 2021: RM25.3 per jam) manakala nilai ditambah per pekerja adalah RM12,192 (ST4 2021: RM13,463 per pekerja).

## PERLOMBONGAN DAN PENGKUARIAN


Produktiviti buruh mengikut nilai ditambah per jam bekerja bagi sektor Perlombongan dan pengkuarian menurun sebanyak 4.8 peratus pada suku ini berbanding pertumbuhan negatif 9.1 peratus pada ST4 2021. Nilai ditambah jatuh 1.1 peratus pada suku pertama 2022 (ST4 2021: -0.6%) manakala jam bekerja meningkat 3.9 peratus (ST4 2021: 9.3%) seperti yang digambarkan dalam Paparan 2.

Produktiviti buruh per pekerja jatuh 3.6 peratus berbanding negatif 10.5 peratus manakala pekerja meningkat 2.6 peratus (ST4 2021: 11.0%).

Nilai produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja adalah RM530.9 pada ST1 2022 (ST4 2021: RM532.4 per jam) manakala nilai ditambah per pekerja adalah RM317,500 (ST4 2021: RM314,462 per pekerja).


## PEMBUATAN

**Produktiviti buruh per jam bekerja bagi sektor Pembuatan turun 0.1 peratus pada ST1 2022 (ST4 2021: 4.6%) seperti di Paparan 3.** Nilai ditambah bagi sektor ini berkembang 6.6 peratus (ST4 2021: 9.1%) manakala jam bekerja meningkat 6.8 peratus (ST4 2021: 4.3%). Pertumbuhan tertinggi produktiviti buruh dicatatkan oleh Produk elektrik, elektronik & optikal (8.0%), Produk mineral bukan logam, logam asas & produk logam yang direka (3.3%) serta Produk kayu, perabot, keluaran kertas & percetakan (0.4%). Sementara itu, **produktiviti buruh yang digambarkan sebagai nisbah nilai ditambah per pekerja meningkat 2.8 peratus** (ST4 2021: 5.3%) manakala **pekerja kekal dengan pertumbuhan positif sebanyak 3.7 peratus** berbanding 3.6 peratus pada ST4 2021.

Dari segi nilai produktiviti buruh, **nilai ditambah per jam bekerja dan nilai ditambah masing-masing adalah RM54.9 per jam** (ST4 2021: RM58.3 per jam) dan **RM32,270** (ST4 2021: RM34,308 per pekerja).

## DEMBINAAN


Pada ST1 2022, produktiviti buruh mengikut nilai ditambah per jam bekerja bagi sektor Pembinaan mencatatkan penurunan **8.2 peratus** berbanding pertumbuhan negatif dua digit pada 11.0 peratus suku sebelumnya. Nilai ditambah bagi sektor ini jatuh 6.2 peratus (ST4 2021: -12.2%) manakala jam bekerja meningkat kepada 2.3 peratus berbanding negatif 1.4 peratus pada ST4 2021 (**Paparan 4**).

Pada suku ini, produktiviti buruh mengikut **nilai ditambah per pekerja bagi sektor ini** kekal merosot **pada 5.5 peratus** (ST4 2021: -11.2%) dengan pekerja turun marginal 0.6 peratus berbanding negatif 1.2 peratus suku sebelumnya.

Nilai produktiviti buruh yang diukur sebagai **nilai ditambah per jam bekerja** adalah **RM15.6** (ST4 2021: RM15.5 per jam) manakala **nilai ditambah per pekerja** adalah **RM9,351** (ST4 2021: RM9,080 per pekerja).

#### Produktiviti Buruh Sektor Pembinaan, ST4 2021 - ST1 2022






## PERKHIDMATAN

Produktiviti buruh mengikut nilai ditambah per jam bekerja bagi sektor Perkhidmatan bertambah baik **1.2 peratus** (ST4 2021: 0.8%) seperti yang digambarkan dalam **Paparan 5**. Pada ST1 2022, nilai ditambah bagi sektor ini berkembang kukuh pada 6.5 peratus (ST4 2021: 3.2%) manakala jam bekerja meningkat 5.2 peratus (ST4 2021: 2.5%). Pada suku ini, empat subsektor merekodkan pertumbuhan positif bagi produktiviti buruh per jam bekerja dengan peningkatan tertinggi dicatatkan oleh Pengangkutan & penyimpanan (21.7%), Makanan & minuman dan penginapan (14.6%), diikuti oleh Hartanah & perkhidmatan perniagaan (6.2%) serta Perkhidmatan lain (2.6%). Sementara itu, produktiviti buruh yang digambarkan sebagai nisbah **nilai ditambah per pekerja** meningkat **3.6 peratus** (ST4 2021: 1.1%) manakala pekerja bertambah 2.8 peratus (ST4 2021: 2.1%).

**Nilai ditambah per jam bekerja bagi sektor Perkhidmatan adalah RM38.2** (ST4 2021: RM39.9 per jam) manakala **nilai ditambah per pekerja adalah RM21,918** (ST4 2021: RM22,621 per pekerja).

# LABOUR PRODUCTIVITY PERFORMANCE OF FIRST QUARTER 2022




## MALAYSIA'S LABOUR PRODUCTIVITY

In the first quarter of 2022, Malaysia's labour productivity as measured by value added per hour worked grew at a marginal rate of 0.3 per cent (Q4 2021: 1.3%) as depicted in Chart 1. During this quarter, value added expanded to 5.0 per cent (Q4 2021: 3.6%) while hours worked increased 4.6 per cent (Q4 2021: 2.3%).


Labour Productivity per Hour Worked and Total Hours Worked, Annual Percentage Change, Q1 2016 - Q1 2022



Meanwhile, labour productivity expressed in terms of value added per employment rose 2.7 per cent (Q4 2021: 1.7%) as employment increased 2.2 per cent (Q4 2021: 1.8%) as illustrated in Chart 2.

Labour productivity as measured by value added per hour worked during this quarter was RM40.3 (Q4 2021: RM42.3 per hour) while value added per employment was RM23,129 (Q4 2021: RM24,047 per person).



## AGRICULTURE


In Agriculture sector, labour productivity per hour worked during the quarter declined marginally at 0.2 per cent as against positive growth of 1.7 per cent last quarter. The value added of this sector grew 0.2 per cent (Q4 2021: 2.8%) while total hours worked increased slightly by 0.4 per cent (Q4 2021: 1.1%) as depicted in **Exhibit 1**.

**Labour productivity by value added per employment recorded a slower growth of 1.0 per cent** (Q4 2021: 2.9%). In addition, employment remained in the declining trend at 0.8 per cent as compared to negative 0.1 per cent in the previous quarter.

In Q1 2022, **value added per hour worked for this sector was RM22.9** (Q4 2021: RM25.3 per hour) while **value added per employment was RM12,192** (Q4 2021: RM13,463 per person).

## **MINING AND QUARRYING**


**Labour productivity by value added per hour worked for Mining and quarrying sector fell 4.8 per cent in the quarter** as against negative growth of 9.1 per cent in Q4 2021. Value added dropped 1.1 per cent in the first quarter of 2022 (Q4 2021: -0.6%) while hours worked increased 3.9 per cent (Q4 2021: 9.3%) as shown in **Exhibit 2**.

**Labour productivity per employment decreased 3.6 per cent** as against negative 10.5 per cent while employment increased at 2.6 per cent (Q4 2021: 11.0%).

Level of labour productivity which is measured as **value added per hour worked** was **RM530.9** in **Q1 2022** (Q4 2021: RM532.4 per hour) while **value added** was **RM317,500** (Q4 2021: RM314,462 per person).

## MANUFACTURING


### **Labour productivity per hour worked for Manufacturing declined slightly by 0.1 per cent in Q1 2022**

(Q4 2021: 4.6%) as illustrated in **Exhibit 3**. Value added of this sector grew 6.6 per cent in this quarter (Q4 2021: 9.1%) while hours worked increased 6.8 per cent (Q4 2021: 4.3%). The highest growth of labour productivity were registered by Electrical, electronic & optical products (8.0%), Non-metallic mineral products, basic metal & fabricated metal products (3.3%) and Wood products, furniture, paper products & printing (0.4%). Meanwhile, **labour productivity expressed as ratio of value added per employment went up 2.8 per cent** (Q4 2021: 5.3%) while **employment remains its positive growth at 3.7 per cent** as compared to 3.6 per cent in Q4 2021.

In terms of labour productivity level, the **value added per hour worked and value added per employment were RM54.9** (Q4 2021: RM58.3 per hour) and **RM32,270** (Q4 2021: RM34,308 per person), respectively.

## CONSTRUCTION


In Q1 2022, labour productivity by value added per hour worked for Construction posted a decrease of 8.2 per cent as opposed to double digit negative growth of 11.0 per cent in last quarter. Value added in this sector decreased 6.2 per cent (Q4 2021: -12.2%) while hours worked rebounded to 2.3 per cent as against negative 1.4 per cent in Q4 2021 (**Exhibit 4**).

During the quarter, labour productivity in terms of value added per employment for this sector remained subdued at 5.5 per cent (Q4 2021: -11.2%) as employment decreased marginally 0.6 per cent as against negative 1.2 per cent in last quarter.

Level of labour productivity which is measured as value added per hour worked was RM15.6 (Q4 2021: RM15.5 per hour) while value added per employment was RM9,351 (Q4 2021: RM9,080 per person).

Q4 2021 - Q1 2022**






## SERVICES

**Labour productivity in terms of value added per hour worked for Services sector improved 1.2 per cent** (Q4 2021: 0.8%) as portrayed in **Exhibit 5**. In Q1 2022, value added of this sector expanded strongly at 6.5 per cent (Q4 2021: 3.2%) while hours worked went up 5.2 per cent (Q4 2021: 2.5%). During the quarter, four sub-sectors posted positive growths for labour productivity per hour worked with the largest increase was registered by Transportation & storage (21.7%), Food & beverages and accommodation (14.6%), followed by Real estate & business services (6.2%) and Other services (2.6%). Meanwhile, labour productivity expressed as the ratio of **value added per employment stepped up to 3.6 per cent** (Q4 2021: 1.1%) while employment increased 2.8 per cent (Q4 2021: 2.1%).

**Value added per hour worked for Services sector was RM38.2** (Q4 2021: RM39.9 per hour) while **value added per employment was RM21,918** (Q4 2021: RM22,621 per person).



# NOTA TEKNIKAL

*Technical Notes*

## PENGENALAN

Penerbitan ini membentangkan statistik produktiviti buruh suku tahunan bagi tempoh suku pertama 2018 hingga suku pertama 2022 mengikut jenis aktiviti ekonomi. Statistik ini disusun berdasarkan konsep dan panduan yang digariskan dalam ***System of National Accounts 2008, United Nations*** dan ***The Organisation for Economic Co-operation and Development (OECD) Manual: Measuring Productivity***.

Statistik yang tersedia dalam penerbitan ini adalah nilai dan perubahan peratusan tahunan. Namun, metodologi penyusunan telah ditambah baik dengan komponen baharu iaitu indeks produktiviti buruh per jam bekerja dan indeks produktiviti buruh per pekerja yang diterbitkan kepada umum bermula pada suku pertama 2022. Indeks produktiviti buruh ini menggunakan 2015 sebagai tahun asas.

## SKOP DAN LIPUTAN

Produktiviti buruh meliputi lima sektor iaitu Pertanian, Perlombongan & pengkuarian, Pembuatan, Pembinaan dan Perkhidmatan berdasarkan Piawaian Klasifikasi Industri Malaysia (MSIC) 2008 Ver.1.0 yang selaras dengan International Standard Industrial Classification of All Economic Activities (ISIC), Rev. 4 yang diterbitkan oleh United Nations. Pengelasan subsektor dan aktiviti ekonomi adalah seperti paparan di bawah, dengan sektor Pembuatan dan Perkhidmatan boleh diperincikan kepada lapan subsektor.

## KONSEP DAN DEFINISI

Konsep produktiviti buruh boleh didefinisikan nisbah output (barang dan perkhidmatan) kepada input (pekerja jumlah jam atau bekerja). Ia merujuk kepada kecekapan dan keberkesanan setiap pekerja untuk menjana nilai ditambah atau output keseluruhan.

Produktiviti boleh diukur dengan pelbagai kaedah mengikut keperluan dan ketersediaan data. Kaedah-kaedah ini boleh diklasifikasikan kepada dua kategori iaitu **produktiviti faktor tunggal** dan **produktiviti pelbagai faktor**. *Malaysia Productivity Blueprint* (MPB) telah menggariskan penggunaan input buruh sebagai indikator produktiviti sementara itu, selari dengan keperluan Rancangan Malaysia Kesebelas. Namun begitu, faktor-faktor lain yang mempengaruhi nilai ditambah seperti aset dan teknologi tidak boleh diukur melalui kaedah ini.

Penggunaan kaedah produktiviti faktor tunggal boleh memberi kesan kepada nilai produktiviti di mana bagi sesetengah industri ianya mungkin tidak merujuk kepada jumlah sebenar pengeluaran bagi seorang pekerja. Pengguna disarankan menggunakan data indeks dan perubahan peratus bagi tujuan analisis. Nilai produktiviti buruh dalam penerbitan ini adalah sebagai rujukan sahaja dan sebarang analisis perbandingan perlu dibuat secara berhati-hati.

### Nilai ditambah

Merujuk kepada perbezaan di antara output dan penggunaan perantaraan. Output adalah nilai barang dan perkhidmatan yang dikeluarkan. Ini termasuk pengeluaran untuk pasaran, pengeluaran untuk kegunaan sendiri dan pengeluaran bukan pasaran (perkhidmatan kerajaan dan NPISHs). Pengeluaran barang dan perkhidmatan tidak semestinya untuk dijual atau perolehan oleh pertubuhan. Sementara itu, penggunaan perantaraan adalah nilai barang dan perkhidmatan yang digunakan (sebagai input) dalam proses pengeluaran barang dan perkhidmatan tidak termasuk gaji dan upah, susut nilai daripada modal dan faedah bersih yang dibayar.

Nilai ditambah barang dan perkhidmatan dalam aktiviti ekonomi hampir menyamai dengan keuntungan perniagaan, gaji dan upah, susut nilai dan cukai tidak langsung; campur faedah yang dibayar dan tolak faedah yang diterima.

### Pekerja

Merujuk kepada semua orang yang bekerja sekurang-kurangnya sejam semasa minggu rujukan untuk mendapatkan upah, keuntungan atau keuntungan keluarga (sebagai majikan, pekerja, pekerja sendiri atau pekerja keluarga tanpa gaji). Mereka juga dianggap bekerja jika:

- Tidak bekerja semasa minggu rujukan disebabkan sakit, kecederaan, tiada upaya, cuaca buruk, bercuti, pertelingkahan buruh dan sebab-sebab sosial atau keagamaan tetapi mempunyai pekerjaan, ladang, perusahaan atau perusahaan keluarga lain untuk kembali bekerja.
- Tidak bekerja buat sementara waktu tetapi bergaji dan pasti akan dipanggil bekerja semula.
- Bekerja kurang daripada 30 jam semasa minggu rujukan disebabkan bentuk kerja atau disebabkan kurang kerja dan berkeupayaan serta sanggup menerima tambahan bilangan jam bekerja. Kumpulan ini merupakan guna tenaga tidak penuh.

Bagi seseorang yang mempunyai lebih daripada satu pekerjaan, hanya pekerjaan yang mengambil masa terbanyak semasa tempoh rujukan dianggap sebagai pekerjaan utamanya. Jika masa bekerja bagi tiap-tiap pekerjaan itu sama, maka pekerjaan yang menghasilkan pendapatan tertinggi adalah pekerjaan utamanya. Dalam kes di mana bilangan jam bekerja dan pendapatannya adalah sama bagi setiap pekerjaan, di mana dia telah bekerja paling lama dianggap sebagai pekerjaan utamanya.

### Jumlah jam bekerja

Merujuk kepada agregat sebenar jam bekerja dalam tempoh rujukan. Ia adalah hasil darab daripada purata jam bekerja dengan pekerja. Pekerja merujuk kepada keseluruhan pekerja kecuali mereka yang tidak bekerja pada akhir tempoh rujukan kerana sakit, kecederaan, hilang upaya, cuaca buruk, cuti, pertikaian buruh dan sebab sosial atau agama.

### Produktiviti buruh per pekerja

Produktiviti buruh per pekerja ditakrifkan sebagai nisbah output (barang dan perkhidmatan) kepada input (pekerja). Ia mengambarkan jumlah output yang dihasilkan oleh setiap orang yang bekerja sepenuh masa, separuh masa, bekerja sendiri atau pekerja keluarga tanpa gaji yang bekerja sekurang-kurangnya selama satu jam dalam seminggu. Pekerja merujuk kepada keseluruhan pekerja termasuk mereka yang tidak bekerja pada akhir tempoh rujukan kerana sakit, kecederaan, hilang upaya, cuaca buruk, cuti, pertikaian buruh dan sebab sosial atau agama.

### Produktiviti buruh per jam bekerja

Produktiviti buruh per jam bekerja ditakrifkan sebagai nisbah output (barang dan perkhidmatan) kepada input (jumlah jam bekerja). Ia mengambarkan jumlah output yang dihasilkan dalam tempoh sejam berdasarkan kategori pekerja yang bekerja sepenuh masa, separuh masa, bekerja sendiri atau pekerja keluarga tanpa gaji yang bekerja sekurang-kurangnya selama satu jam dalam seminggu. Pekerja merujuk kepada keseluruhan pekerja kecuali mereka yang tidak bekerja pada akhir tempoh rujukan kerana sakit, kecederaan, hilang upaya, cuaca buruk, cuti, pertikaian buruh dan sebab sosial atau agama.

### Indeks produktiviti buruh

Indeks produktiviti buruh (LPI) adalah petunjuk untuk mengukur kecekapan input yang digunakan bagi menjana output dalam tempoh masa tertentu. LPI ditakrifkan sebagai nisbah indeks output (barang dan perkhidmatan) kepada indeks input (pekerja atau jumlah jam bekerja). LPI diukur pada tempoh rujukan berbanding tahun asas 2015, (2015=100).

## KAEDAH PENGANGGARAN PRODUKTIVITI BURUH

Penganggaran produktiviti buruh suku tahunan diukur menggunakan kaedah produktiviti faktor tunggal. Anggaran ini dibuat berdasarkan maklumat nilai ditambah per pekerja atau nilai ditambah per jumlah jam bekerja mengikut aktiviti ekonomi. Pengukuran produktiviti buruh per jam bekerja memberikan gambaran yang lebih baik berkaitan perkembangan produktiviti di dalam ekonomi berbanding produktiviti buruh per pekerja kerana elemen perbezaan komposisi pekerja sepenuh masa/separuh masa telah dihapuskan. Maklumat tambahan berkaitan penganggaran produktiviti buruh boleh diperoleh dari [www.dosm.gov.my](http://www.dosm.gov.my).

Nilai ditambah yang digunakan adalah nilai pada harga malar di mana ia merujuk kepada nilai barang dan perkhidmatan pada harga asas tahun 2015. Pekerja merujuk kepada bilangan keseluruhan pekerja dalam tempoh rujukan manakala jumlah jam bekerja ialah agregat sebenar jam bekerja dalam tempoh rujukan.

Kaedah penganggaran data pekerja adalah berdasarkan data banci dan survei yang dijalankan oleh DOSM serta data pentadbiran daripada pelbagai agensi. Anggaran suku tahunan dan tahunan meliputi keseluruhan pekerja mengikut aktiviti ekonomi. Anggaran pekerja dikira menggunakan kaedah ekstrapolasi yang merujuk kepada pelbagai sumber data manakala jumlah pekerja merujuk kepada penduduk bekerja yang diterbitkan dalam laporan suku tahunan Survei Tenaga Buruh. Perlu diingatkan bahawa anggaran pekerja mengikut aktiviti ekonomi tidak berdasarkan Survei Tenaga Buruh kerana komponen pekerja produktiviti buruh telah mengambil kira penyelarasan sumber data penawaran dan permintaan buruh.



## 9 SUBSEKTOR KEUTAMAAN

Salah satu strategi nasional untuk memacu pertumbuhan dan perkembangan ekonomi secara berterusan adalah melalui kerjasama industri di Malaysia. Oleh itu, kerajaan telah melancarkan **Malaysia Productivity Blueprint (MPB)** pada Mei 2017 sebagai sebahagian daripada Rancangan Malaysia ke-11. Terdapat 9 subsektor keutamaan yang dikenal pasti dan melalui MPB juga boleh menunjukkan potensi pertumbuhan yang tinggi untuk negara. 9 subsektor keutamaan mengikut kategori tiga sektor utama ekonomi ialah sektor Perkhidmatan, Pembuatan dan Pertanian.

9 subsektor keutamaan telah dikenal pasti iaitu Agro-makanan; Kimia dan produk kimia; Elektrik dan elektronik; Mesin dan peralatan; Peruncitan dan makanan & minuman; Pelancongan; Teknologi, maklumat dan Komunikasi; Perkhidmatan profesional; dan Penjagaan kesihatan swasta. Pemilihan 9 subsektor ini berikutan sumbangan sebanyak 30 peratus kepada Keluaran Dalam Negeri Kasar (KDNK) Malaysia dan 40 peratus kepada jumlah pekerja. Subsektor ini diberi keutamaan berdasarkan kriteria berikut:



## PENERBITAN DAN SEMAKAN STATISTIK

Statistik produktiviti buruh yang dilaporkan dalam penerbitan ini bermula dari suku pertama 2018 hingga suku pertama 2022 disusun berdasarkan anggaran Keluaran Dalam Negeri Kasar, jam bekerja dan pekerja. Statistik pekerja telah diselaraskan berdasarkan data terkini banci dan survei yang dilaksanakan oleh Jabatan. Semakan semula statistik produktiviti buruh adalah tertakluk kepada semakan statistik nilai ditambah, jam bekerja dan pekerja.

## INTRODUCTION

This publication presents the quarterly statistics of labor productivity from the first quarter of 2018 to the first quarter of 2022 by economic activity. These statistics are compiled based on the concepts and guidelines outlined in the System of National Accounts 2008, United Nations and The Organisation for Economic Co-operation and Development (OECD) Manual: Measuring Productivity.

Statistics available in this publication are annual values and percentage changes. However, the compilation methodology has been improved with new components namely the index of labour productivity per hour worked and the index of labour productivity per employment that will be available to the public starting in the first quarter of 2022.

## SCOPE AND COVERAGE

Labour productivity involves five sectors namely Agriculture, Mining & Quarrying, Manufacturing, Construction and Services based on the Malaysian Standard Industrial Classification (MSIC) 2008 Ver.1.0 in line with the International Standard Industrial Classification of All Economic Activities (ISIC), Rev. 4 published by the United Nations. The classification of sub-sectors and economic activities is as in exhibit below, with the Manufacturing and Services sectors can be broken down into eight sub-sectors.

## CONCEPT AND DEFINITION

Productivity can be measured by various methods depending on the requirements and availability of data. These methods can be classified into two categories namely Single Factor Productivity and Multifactor Productivity. Malaysia Productivity Blueprint (MPB) has outlined the use of labour input as a productivity indicator in line with the requirement of the Eleventh Malaysia Plan. Meanwhile, other factors influencing value added such as assets and technology cannot be measured through this method.

The use of the Single Factor Productivity method affects the productivity values where for certain industries it may not refer to the actual amount of production for an employee. Users are advised to use percentage change data for analysis purposes. The labour productivity values in this publication are for reference only and any comparative analysis should be made with caution.

### **Value added**

*The difference between output and intermediate consumption. It represents the value added of goods and services by economic activity. Hence, it is approximately equivalent to commercial profit, salaries and wages, depreciation and indirect taxes; plus, interest paid and less interest received.*

### **Employment**

*All persons who, at any time during the reference week worked at least one hour for pay, profit or family gain (as an employer, employee, own-account worker or unpaid family worker). They are also considered as employed if they:*

- *Did not work during the reference week because of illness, injury, disability, bad weather, leave, labour dispute and social or religious reasons but had a job, farmer enterprise or other family enterprise to return to.*
- *Were temporary laid-off with pay and would definitely be called back to work.*
- *Were employed less than 30 hours during the reference week because of the nature of their work or due to insufficient work and are able and willing to accept additional hours of work. This group is underemployed.*

*For a person having more than one job, only the job at which he worked for the longest number of hours during the reference week is treated as his principal occupation. Should the number of hours worked for each job is the same, then the job with the highest income is the principal occupation. In cases where the number of hours worked and the income earned from each job are the same, the job at which he was working for the longest period of time is considered as the principal occupation.*

### Total hours worked

*Total number of hours worked during the reference period. It is defined as the product of the average hours worked and the number of people in employment. Employment refers to is the overall number of employees at the end of the reference period excluding the employees who did not work during the reference period because of illness, injury, disability, bad weather, leave, labour dispute and social/ religion reason.*

$$\text{THW} = \text{AHW} \times \text{EmpHW}$$

whereas:

### Labour productivity value added per employment

*Labour productivity per employment is measured as output (goods and services) per input ratio (employment). It is defined as the output produced by persons who worked for pay or profit (or pay in kind) and persons who were temporarily absent from work due to illness, maternity, holiday, training or labour dispute; and unpaid family workers who worked for at least one hour within a week. Employment refers to is the overall number of employees at the end of the reference period excluding the employees who did not work during the reference period because of illness, injury, disability, bad weather, leave, labour dispute and social/ religion reason.*

$$\text{LPE} = \frac{\text{VA}}{\text{Emp}}$$

whereas:

<b>LPE</b>	<i>labour productivity per employment</i>
<b>VA</b>	<i>value added</i>
<b>Emp</b>	<i>total employment</i>

### Labour productivity value added per hour worked

*Labour productivity per hour worked is defined as the ratio of output (goods and services) to input (total working hours). Labour productivity by number of working hours reflects the amount of output produced within an hour based on the category of employees either in full time, part time or self-employed. Employment refers to is the overall number of employees at the end of the reference period excluding the employees who did not work during the reference period because of illness, injury, disability, bad weather, leave, labour dispute and social/ religion reason.*

$$\text{LPHW} = \frac{\text{VA}}{\text{HW}}$$

## Labour productivity index

*Index of labour productivity (LPI) is an indicator to measure the efficiency of inputs used to generate output in a given period of time. LPI is defined as the ratio of the output index (goods and services) to the input index (employees or total hours worked).*

***I<sub>i</sub>*** input index (employment or total hour worked)

## GENERAL APPROACH OF LABOUR PRODUCTIVITY ESTIMATION

*Quarterly labour productivity estimation is measured using the Single Factor Productivity method. This estimate is based on information of value added with total hours worked and total employment by industry. Measurement of labour productivity per hour worked provides a better picture of the development of productivity in the economy than labour productivity per employee because the element of difference in the composition of full-time/part-time workers has been eliminated. *The value added used at constant prices where it refers to the value of goods and services at 2015 prices. Total employment refers to the overall number of employees in the reference period. Meanwhile, total hours worked are the aggregate number of hours actually worked during the period in employees and self-employment jobs.*

*The methodology of estimating employment data are based on the calibration of household information namely Labour Force Statistics and Informal Sector Workforce Statistics and information of establishment from Monthly Manufacturing Statistics, Quarterly Services Statistics, Quarterly Employment Statistics, Economic Census and Annual Economic Statistics.*


## 9 PRIORITY SUB-SECTORS

*Unlocking greater productivity within industry in Malaysia is one of the national strategies to drive continuous economic growth and expansion. In line with this, the Government launched the Malaysia Productivity Blueprint (MPB) in May 2017 as part of the 11th Malaysia Plan. Within the MPB, 9 priority sub-sectors were identified as presenting high potential growth for the country. The 9 priority sub-sectors are under three main economic sectors namely Services, Manufacturing and Agriculture.*

9 priority sub-sectors are identified as retail and food & beverages (F&B); electrical and electronics (E&E); chemicals and chemical products; agro-food; professional services; tourism; information, communication and technology (ICT); machinery and equipment; and private healthcare. Combined, the 9 priority sub-sectors selected contribute 30 per cent of Malaysia's Gross Domestic Product (GDP) and 40 per cent of total employment. These sub-sectors are prioritised based on the following criteria:



9 priority sub-sectors to drive the implementation of productivity initiatives as outlined by the Malaysia Productivity Blueprint (MPB) are as follows:




Labour productivity is compiled by kind of economic activity based on Malaysia Standard Industrial Classification 2008 Ver. 1.0 as shown in table below.
