Penerbitan ini membentangkan anggaran tahunan Akaun Pengeluaran dan Perbelanjaan Negara bagi tahun 2015 hingga 2021 yang merangkumi anggaran statistik akaun negara tahunan mengikut aktiviti ekonomi dan jenis perbelanjaan pada harga semasa dan harga malar tahun asas 2015.

Anggaran penyusunan ini telah mengguna pakai saranan daripada Sistem Akaun Negara 2008. Anggaran Keluaran Dalam Negeri Kasar (KDNK) pada tahun 2019 telah dimuktamadkan berdasarkan data terkini daripada penyiasatan tahunan dan pelbagai sumber data. Semakan semula data telah dilaksanakan bagi KDNK tahun 2020, manakala KDNK tahun 2021 dianggar berdasarkan data awalan.

PREFACE

This publication presents the annual estimates of National Production and Expenditure Accounts for year 2015 to 2021 which contains statistics of annual national accounts estimates by economic activity and type of expenditure in both current and constant prices at base year 2015.

The estimates are based on recommendations of the System of National Accounts 2008. Gross Domestic Product (GDP) estimates for year 2019 were finalised based on latest annual surveys and various data sources. Revisions of data were incorporated in 2020 GDP, whilst the 2021 GDP estimates were based on preliminary data.

Summary findings of Malaysia's economy for the year 2021 are presented in the first section of this publication, followed by series of GDP data in tables and the last section would be technical notes for user reference. Methodology, data sources and glossary are accessible from the Department's portal.

The Department acknowledges the cooperation of all parties that have provided the required data and contributed to the success of this publication. Any feedback and suggestions towards improving this publication in future is highly appreciated.

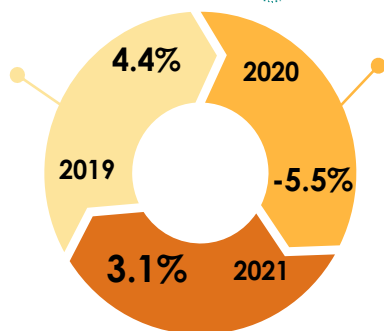

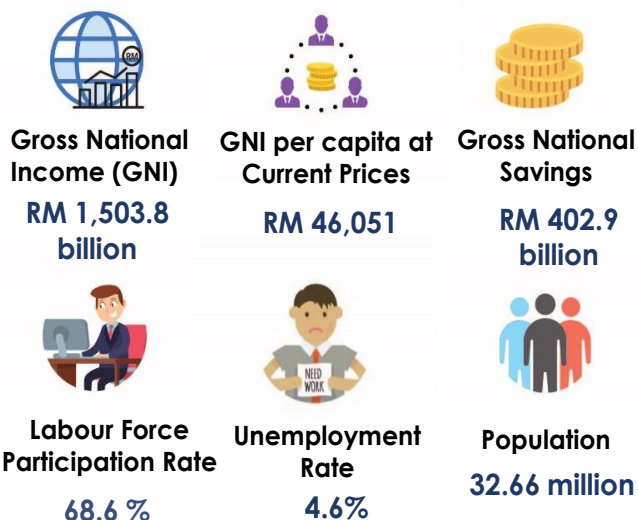

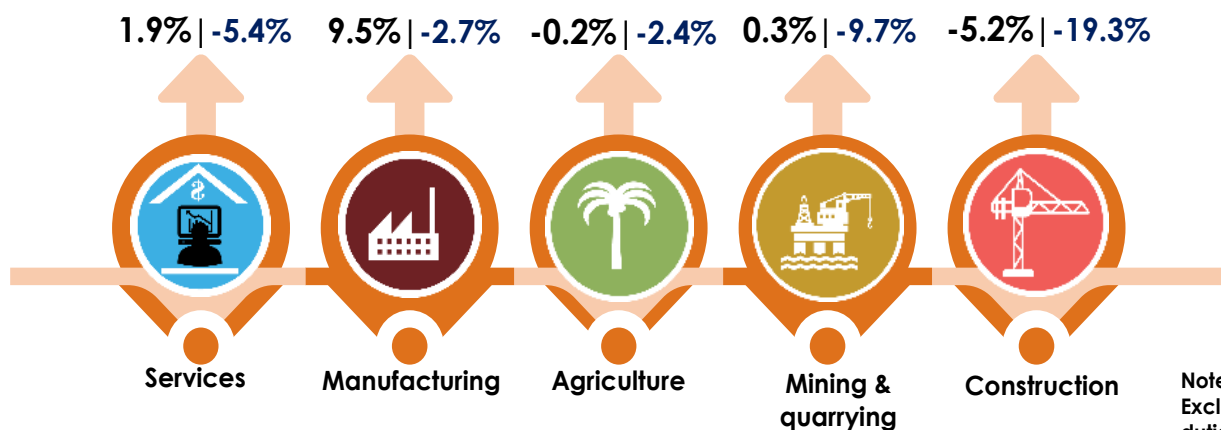

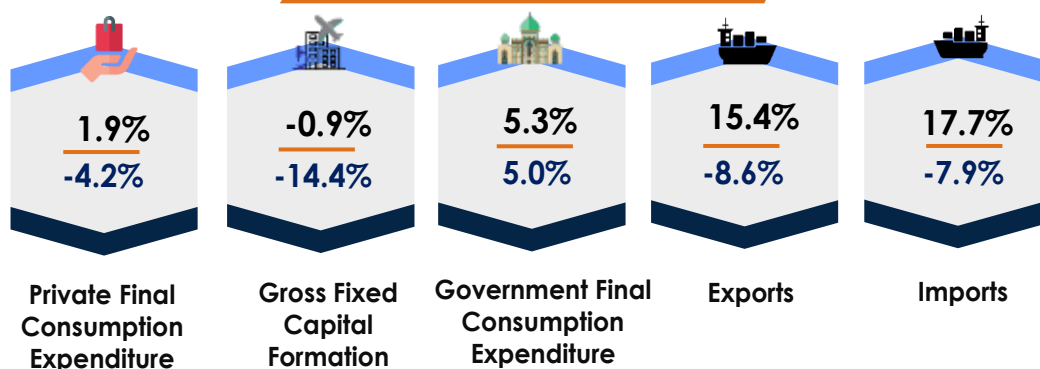
GDP at Constant 2015 Prices

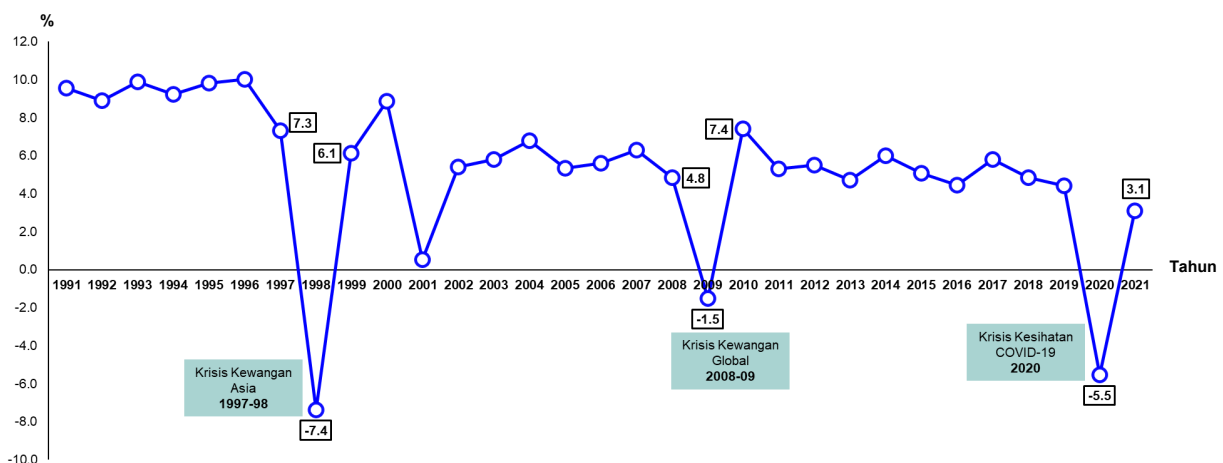
PERTUMBUHAN EKONOMI

Ekonomi Malaysia memperoleh semula momentum pada tahun 2021 dengan pertumbuhan 3.1 peratus daripada negatif 5.5 peratus pada tahun sebelumnya (Carta 1). Prestasi ini dipacu oleh sektor Perkhidmatan dan Pembuatan yang menyumbang 81.3 peratus daripada jumlah Keluaran Dalam Negeri Kasar (KDNK). Dari segi permintaan, Perbelanjaan penggunaan akhir swasta kekal sebagai komponen terbesar dengan sumbangan sebanyak 58.8 peratus pada tahun 2021 (Carta 2).

Walaupun ekonomi Malaysia beransur pulih pada tahun 2021, KDNK masih lebih rendah 2.6 peratus berbanding paras ekonomi pra-pandemik pada tahun 2019, dengan penurunan RM37.2 bilion. Penyusutan ini adalah berikutan penguncupan dalam kesemua aktiviti ekonomi utama kecuali Pembuatan yang pulih 6.6 peratus dari paras ekonomi pada tahun 2019.

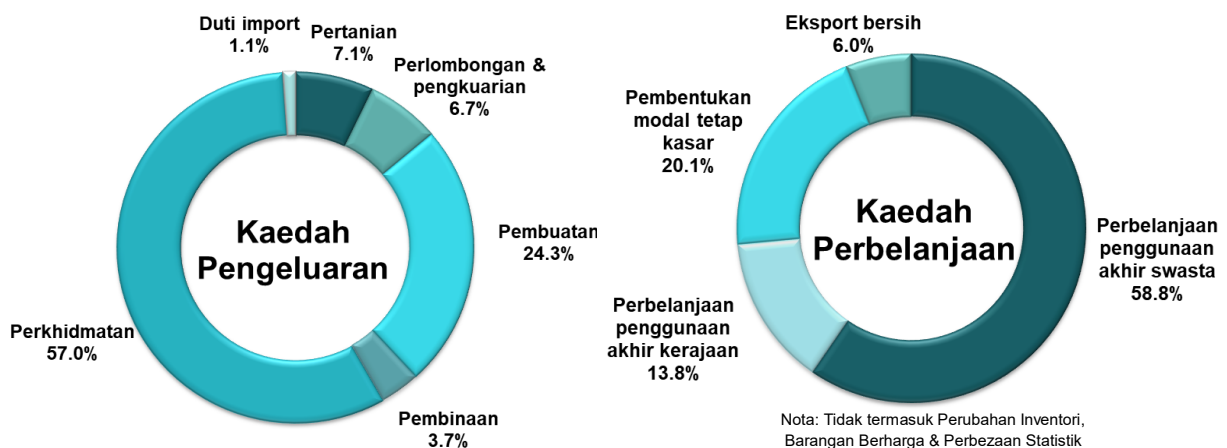
KDNK Malaysia pada harga semasa adalah berjumlah RM1.55 trilion pada tahun 2021, manakala RM1.39 trilion pada harga malar. Selari dengan prestasi keseluruhan, Pendapatan Negara Kasar per kapita meningkat kepada RM46,051 daripada RM42,643 pada tahun sebelumnya.

Carta 2 KDNK - Sumbangan Peratusan pada Harga Malar 2015

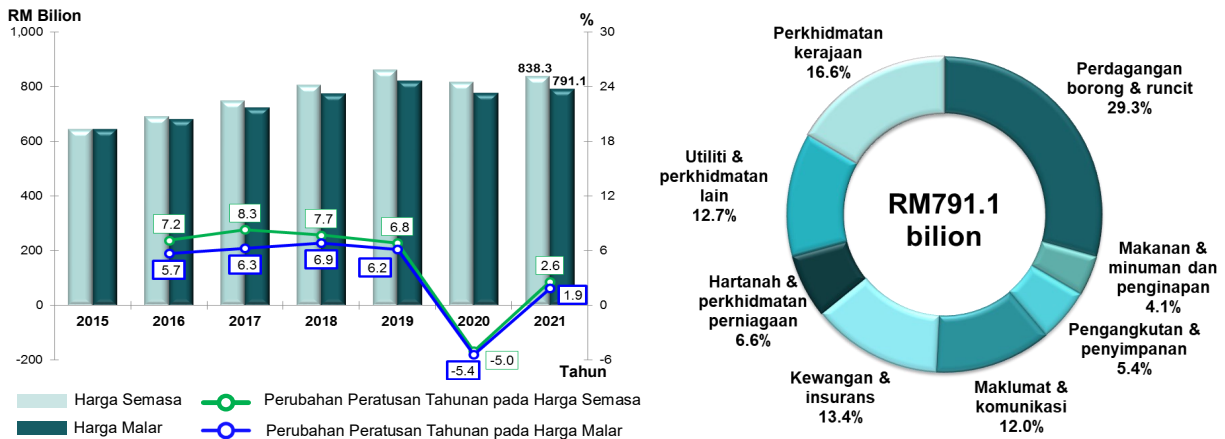

PERKHIDMATAN

Sektor **Perkhidmatan** kembali pulih kepada 1.9 peratus pada tahun 2021 daripada negatif 5.4 peratus pada tahun sebelumnya seperti di Carta 3. Prestasi ini disokong oleh pertumbuhan yang lebih kukuh dalam subsektor utama seperti Kewangan dan insurans pada 10.0 peratus (2020: 2.9%), Maklumat & komunikasi pada 6.3 peratus (2020: 6.0%) dan Perdagangan borong & runcit pada 1.6 peratus (2020: -6.0%). Walau bagaimanapun, Makanan & minuman dan penginapan merosot 11.0 peratus (2020: -26.7%).

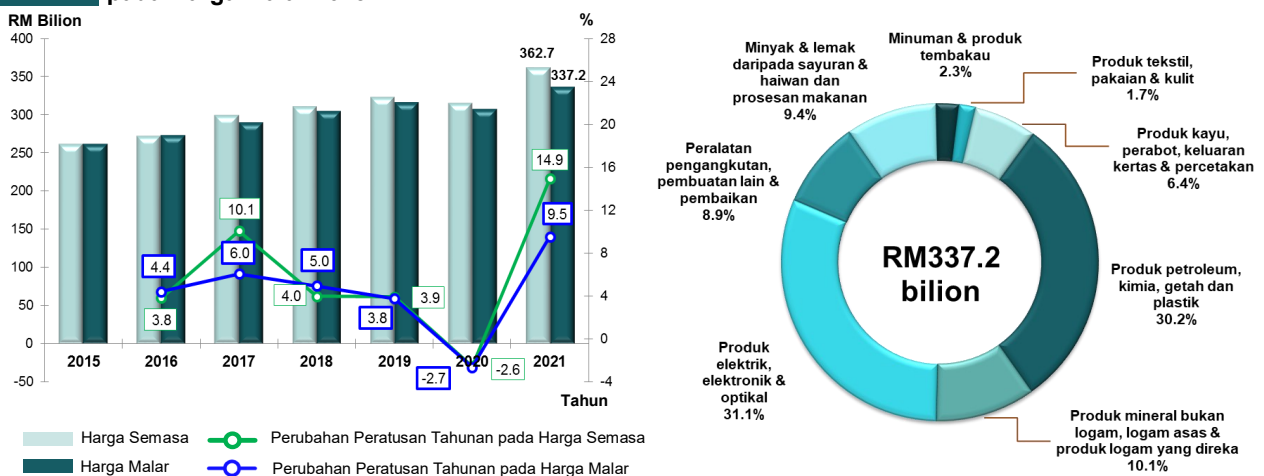

PEMBUATAN

Sektor **Pembuatan** meningkat 9.5 peratus daripada negatif 2.7 peratus pada tahun 2020 seperti di Carta 4. Pertumbuhan kukuh dalam sektor Pembuatan dipacu oleh pertumbuhan dua digit subsektor utama iaitu Komponen & papan elektronik, peralatan komunikasi dan elektronik pengguna pada 16.0 peratus (2020: 3.7%), Produk petroleum bertapis pada 13.0 peratus (2020: -9.6%) dan Bahan kimia & produk kimia dan produk farmaseutikal pada 10.3 peratus (2020: -4.6%). Sebaliknya, Minyak dan lemak daripada sayuran & haiwan menyusut 9.1 peratus (2020: -2.8%).

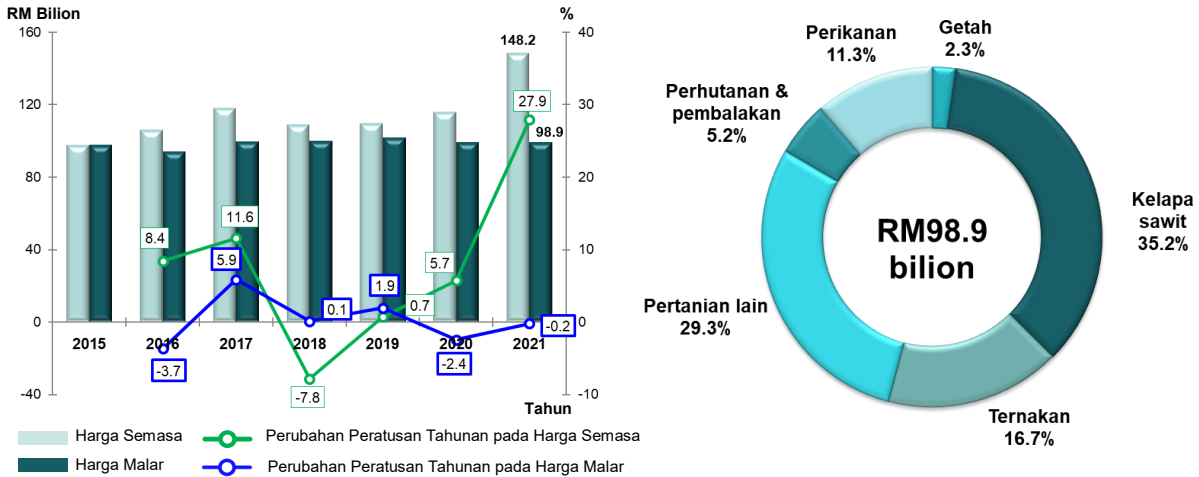

PERTANIAN

Sektor **Pertanian** menurun marginal sebanyak 0.2 peratus berbanding negatif 2.4 peratus pada tahun 2020 (Carta 5). Penurunan ini disebabkan oleh subsektor Kelapa sawit dan Getah yang masing-masing menyusut 5.6 peratus (2020: -3.6%) dan 8.4 peratus (2020: -18.6%). Walau bagaimanapun, subsektor Ternakan dan Pertanian lain kekal positif masing-masing pada 3.2 peratus (2020: 3.5%) dan 5.8 peratus (2020: 3.8%).

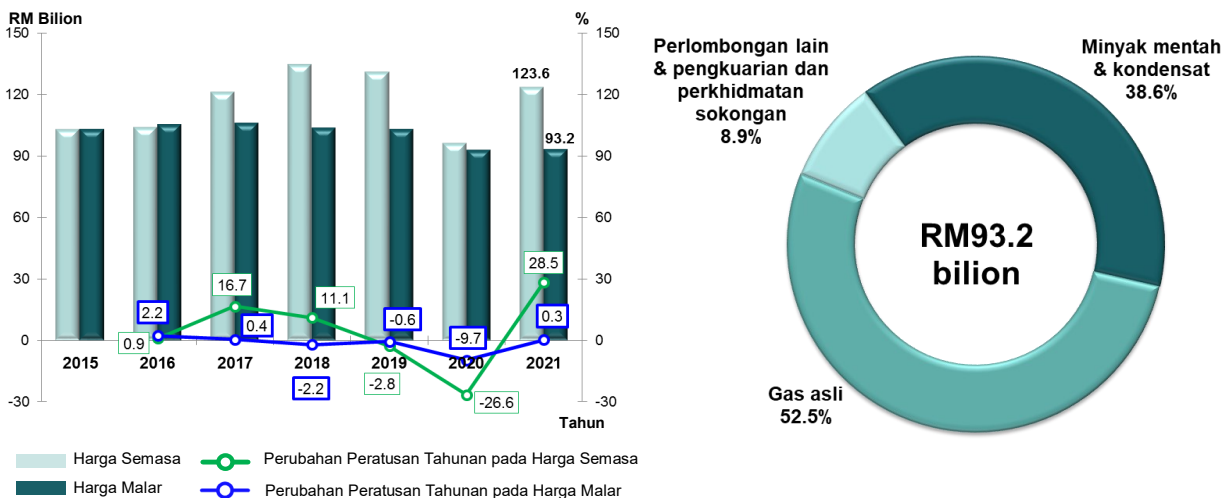

PERLOMBONGAN DAN PENGKUARIAN

Sektor **Perlombongan dan pengkuarian** meningkat 0.3 peratus daripada negatif 9.7 peratus pada tahun 2020 seperti di Carta 6. Peningkatan ini disumbangkan oleh subsektor Gas asli yang pulih kepada 6.6 peratus (2020: -9.4%). Sementara itu, Minyak mentah & kondensat dan Perlombongan lain & pengkuarian dan perkhidmatan sokongan masing-masing menyusut 6.5 peratus (2020: -9.5%) dan 3.1 peratus (2020: -12.6%).

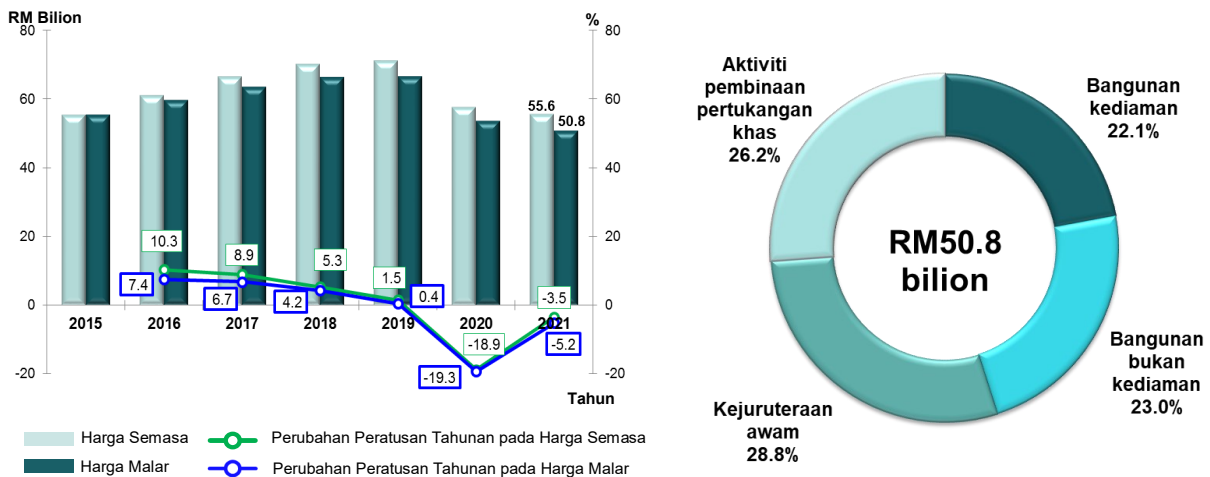

PEMBINAAN

Sektor **Pembinaan** menyusut 5.2 peratus berbanding negatif 19.3 peratus pada tahun sebelumnya (Carta 7). Penyusutan ini sebahagian besarnya dipengaruhi oleh penurunan 18.1 peratus dalam Kejuruteraan awam (2020: -28.1%). Tambahan lagi, Bangunan kediaman dan Bangunan bukan kediaman masing-masing menurun 12.6 peratus (2020: -16.5%) dan 2.2 peratus (2020: -15.8%). Walau bagaimanapun, Aktiviti pembinaan pertukangan khas mencatatkan pertumbuhan 20.6 peratus (2020: -8.9%).

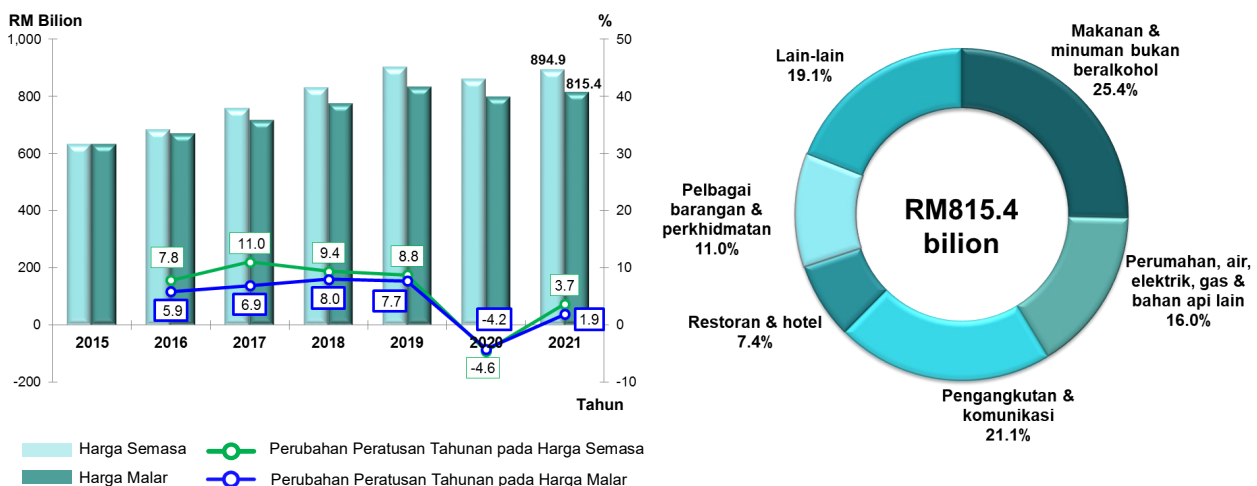


PERBELANJAAN PENGGUNAAN AKHIR SWASTA

Perbelanjaan penggunaan akhir swasta meningkat sebanyak 1.9 peratus pada tahun 2021 selepas mencatatkan kemerosotan 4.2 peratus pada tahun sebelumnya seperti di Carta 8. Momentum pertumbuhan ini didorong oleh penggunaan ke atas Makanan & minuman bukan alkohol, Komunikasi dan Perumahan, air, elektrik, gas & bahan api lain.

Sumbangan perbelanjaan ke atas perkhidmatan kepada jumlah perbelanjaan penggunaan swasta menurun daripada 46.8 peratus pada tahun 2020 kepada 46.0 peratus. Sementara itu, sumbangan perbelanjaan bagi barangan meningkat kepada 54.0 peratus (2020: 53.2%) yang terdiri daripada barangan tidak tahan lama (74.1%) dan barangan tahan lama (15.2%).

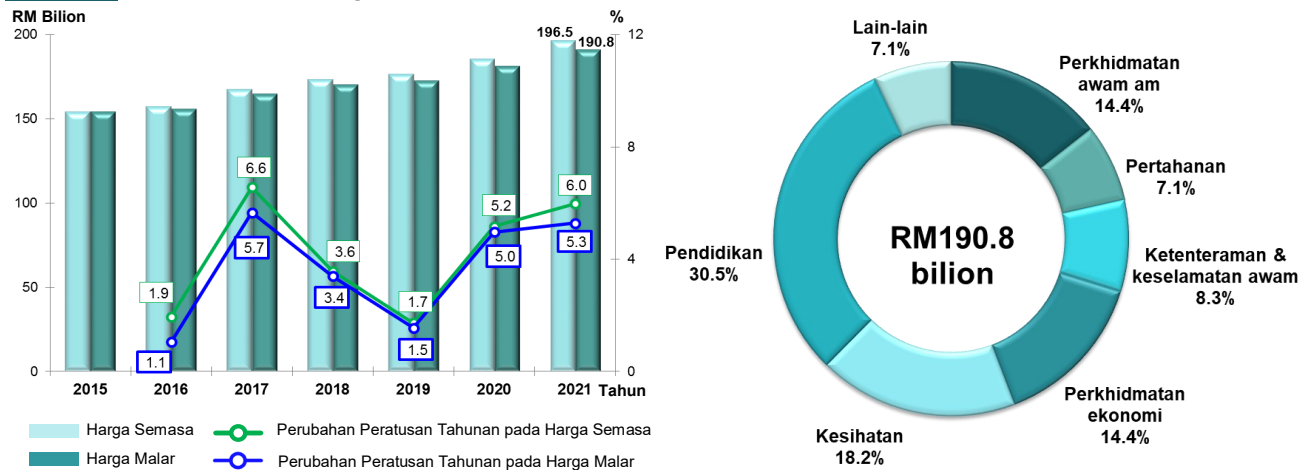

PERBELANJAAN PENGGUNAAN AKHIR KERAJAAN

Perbelanjaan penggunaan akhir kerajaan terus meningkat kepada 5.3 peratus berbanding 5.0 peratus pada tahun sebelumnya (Carta 9). Pertumbuhan dalam perbelanjaan ke atas kesihatan, pendidikan dan kemudahan perumahan & kemasyarakatan telah merangsang keseluruhan perbelanjaan kerajaan.

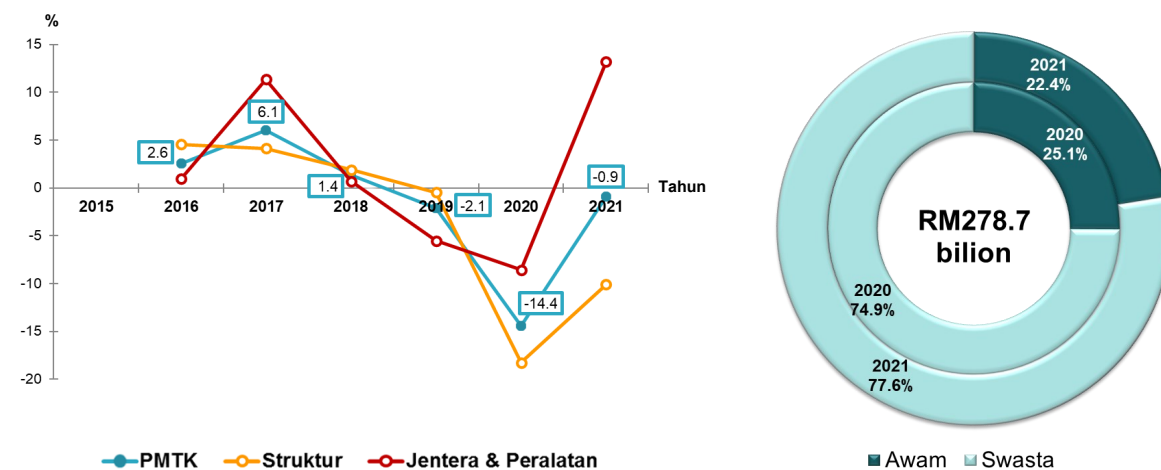


PEMBENTUKAN MODAL TETAP KASAR

Pembentukan modal tetap kasar (PMTK) menyusut marginal 0.9 peratus daripada penurunan 14.4 peratus pada tahun sebelumnya (Carta 10). Penyusutan yang lebih perlahan ini dipengaruhi oleh pemulihan dalam Jentera & peralatan dan Aset lain yang masing-masing meningkat kepada 13.2 peratus dan 0.6 peratus. Walau bagaimanapun, Struktur menyusut 10.1 peratus berbanding negatif 18.3 peratus pada tahun 2020.

Dari segi sektor, sektor Swasta (sumbangan: 77.6%) telah pulih kepada 2.6 peratus daripada pertumbuhan negatif 11.9 peratus pada tahun 2020. Namun begitu, sektor Awam menurun 11.3 peratus daripada penguncupan 21.2 peratus pada tahun sebelumnya dan telah memperlahankan prestasi sektor ini.

Carta 10 PMTK - Nilai, Perubahan Peratusan Tahunan dan Sumbangan Peratusan pada Harga Malar 2015

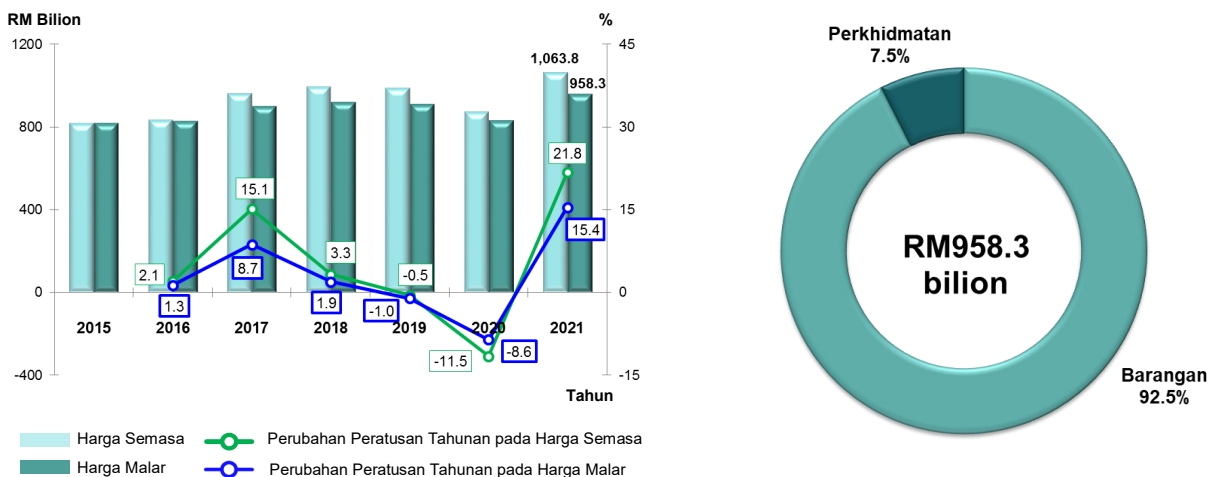


EKSPORT DAN IMPORT

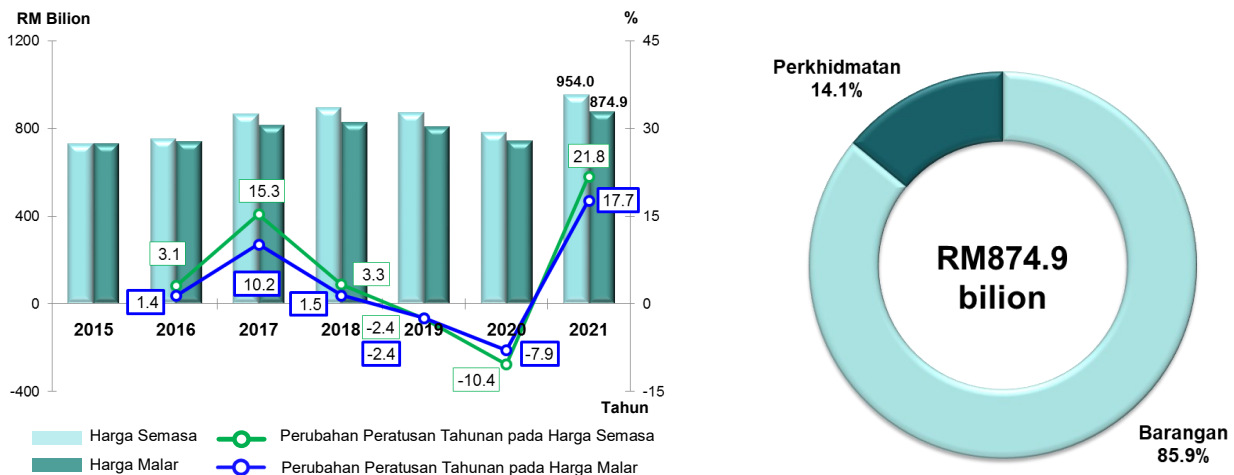
Eksport melonjak kepada 15.4 peratus berbanding kejatuhan 8.6 peratus pada tahun sebelumnya (Carta 11). Prestasi ini dirangsang oleh Eksport barangan dengan peningkatan 18.1 peratus (2020: -0.7%) dan menyumbang sebanyak 92.5 peratus daripada jumlah Eksport. Sementara itu, Eksport perkhidmatan menyusut 9.6 peratus daripada negatif 47.8 peratus pada tahun 2020.

Import menokok kepada 17.7 peratus (2020: -7.9%) seperti yang digambarkan dalam Carta 12. Kedua-dua Import barangan dan perkhidmatan pulih masing-masing dengan pertumbuhan 20.5 peratus dan 3.2 peratus. Import barangan menyumbang 85.9 peratus daripada jumlah Import keseluruhan.

SEMAKAN

Anggaran KDNK bagi tahun 2019 telah dimuktamadkan berdasarkan sumber data yang terkini. Anggaran KDNK bagi tahun 2020 telah disemak semula berdasarkan ketersediaan sumber data baharu. Pada tahun berikutnya, anggaran KDNK merupakan data awalan bagi tahun 2021.

ECONOMIC GROWTH

Malaysia's economy regained its momentum in 2021, with a 3.1 per cent growth from the previous year's negative 5.5 per cent (Chart 1). The performance was driven by the Services and Manufacturing sectors, which constituted 81.3 per cent of total Gross Domestic Product (GDP). In terms of demand, Private final consumption expenditure remained the largest component with a share of 58.8 per cent in 2021 (Chart 2).

Despite Malaysia's gradual economic recovery in 2021, the GDP is still 2.6 per cent lower than pre-pandemic levels in 2019, with an RM37.2 billion decrease. The dropped was influenced by contractions in all major economic sectors except Manufacturing, which recovered 6.6 per cent from the 2019 economic level.

Malaysia's GDP at current prices was RM1.55 trillion in 2021, while it was RM1.39 trillion at constant prices. In tandem with the overall performance, the Gross National Income per capita surged to RM46,051 from RM42,643 the previous year.

Chart 1 GDP - Annual Percentage Change at Constant Prices

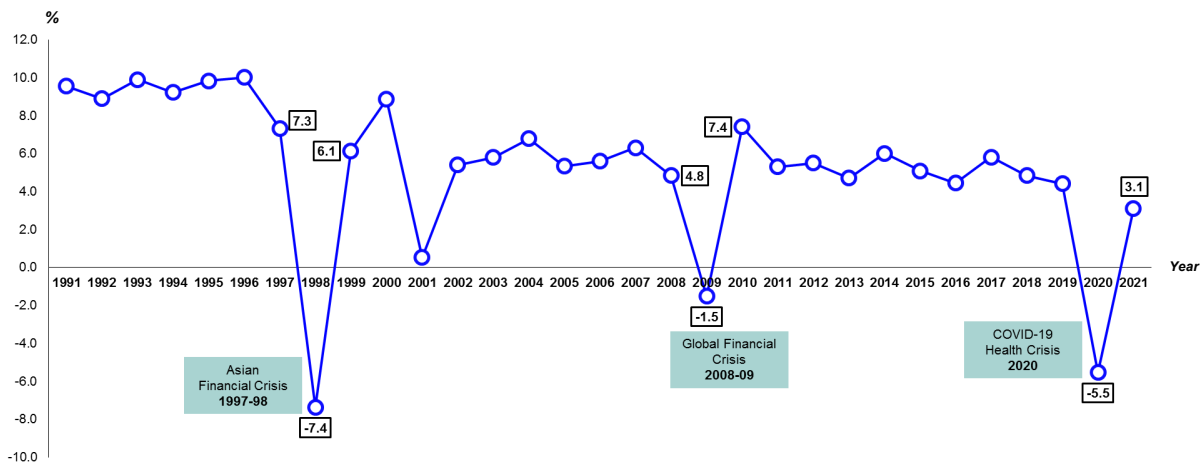
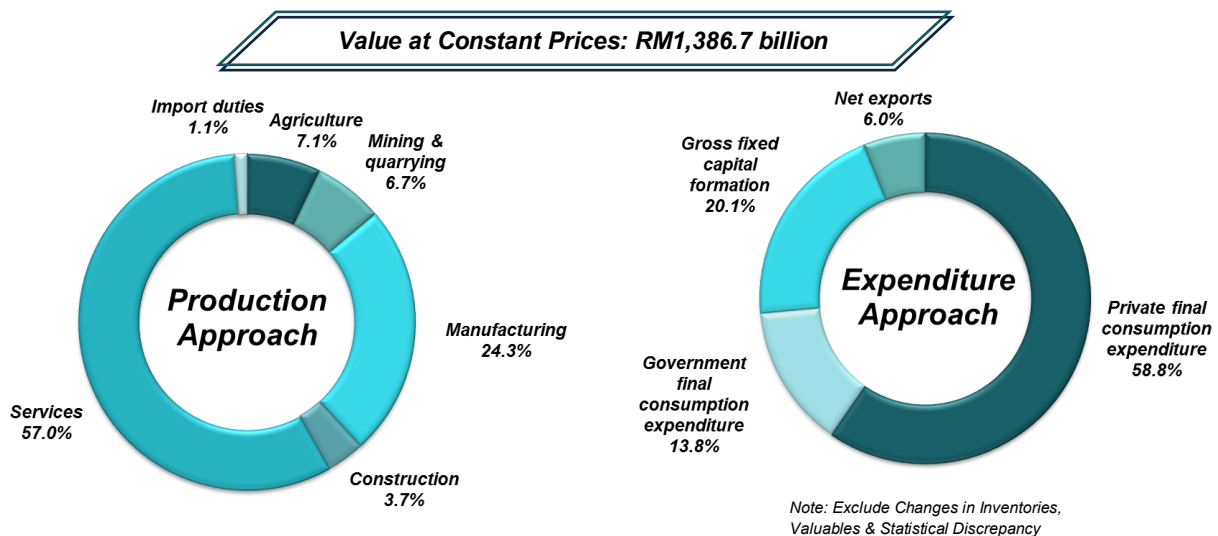


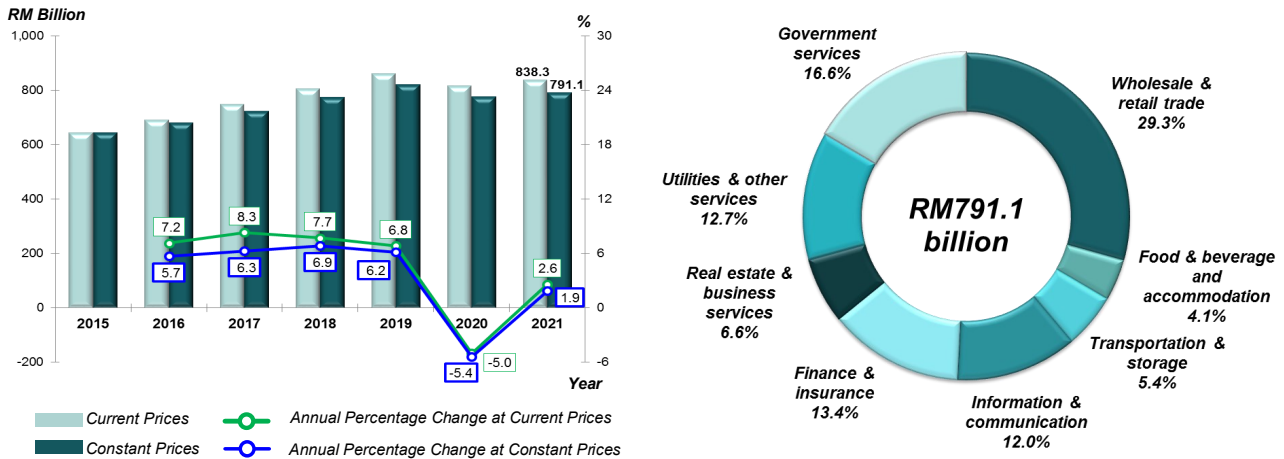
Chart 2 GDP - Percentage Share at Constant 2015 Prices



SERVICES

The **Services** sector rebounded to 1.9 per cent in 2021 from a negative 5.4 per cent the previous year, as illustrated in Chart 3. The performance was supported by stronger growth in major sub-sectors, such as Finance and insurance at 10.0 per cent (2020: 2.9%), Information & communication at 6.3 per cent (2020: 6.0%) and Wholesale & retail trade at 1.6 per cent (2020: -6.0%). Nonetheless, Food & beverage and accommodation fell 11.0 per cent (2020: -26.7%).

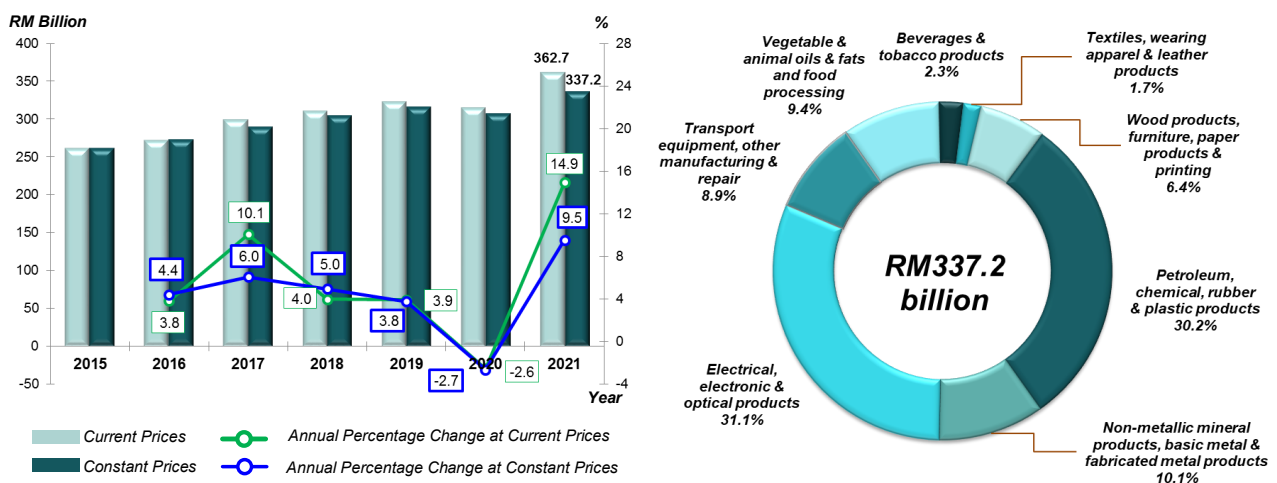
Chart 3 Services - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



MANUFACTURING

The **Manufacturing** sector surged to 9.5 per cent from a negative 2.7 per cent in 2020, as shown in Chart 4. Strong growth in the Manufacturing sector was driven by double-digit growth in major sub-sectors, primarily Electronic components & boards, communication equipment and consumer electronics at 16.0 per cent (2020: 3.7%), Refined petroleum products at 13.0 per cent (2020: -9.6%) and Chemicals & chemical products and pharmaceutical products at 10.3 per cent (2020: -4.6%). On the other hand, Vegetable and animal oils & fats decreased 9.1 per cent (2020: -2.8%).

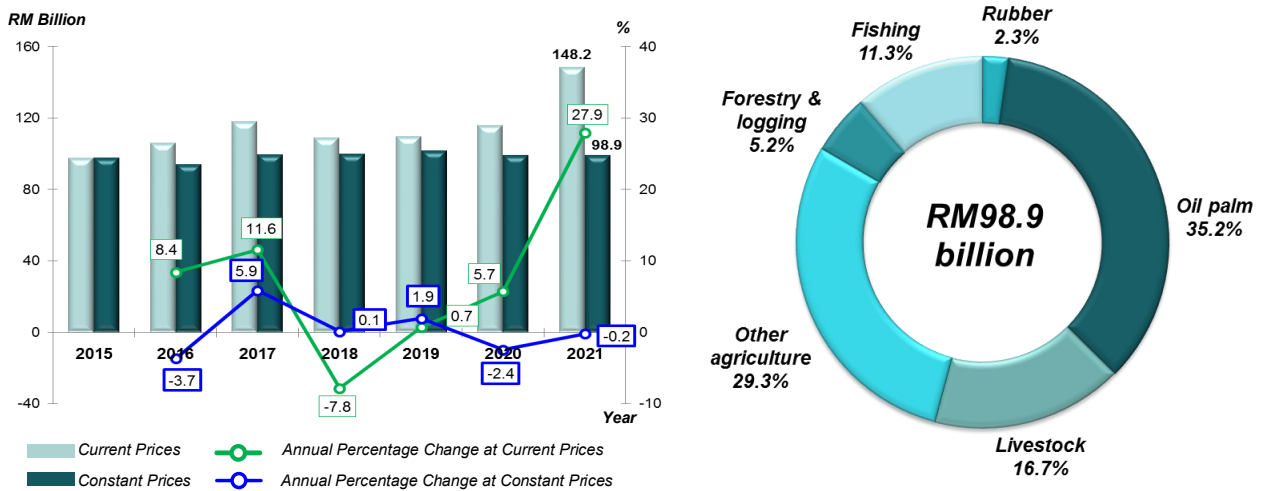
Chart 4 Manufacturing - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



AGRICULTURE

The **Agriculture** sector descended marginally by 0.2 per cent, compared to a negative 2.4 per cent in 2020 (Chart 5). The downturn was attributed to the Oil palm and Rubber sub-sectors, which fell by 5.6 per cent (2020: -3.6%) and 8.4 per cent (2020: -18.6%) respectively. Nevertheless, the Livestock and Other agriculture sub-sectors remained positive at 3.2 per cent (2020: 3.5%) and 5.8 per cent (2020: 3.8%) respectively.

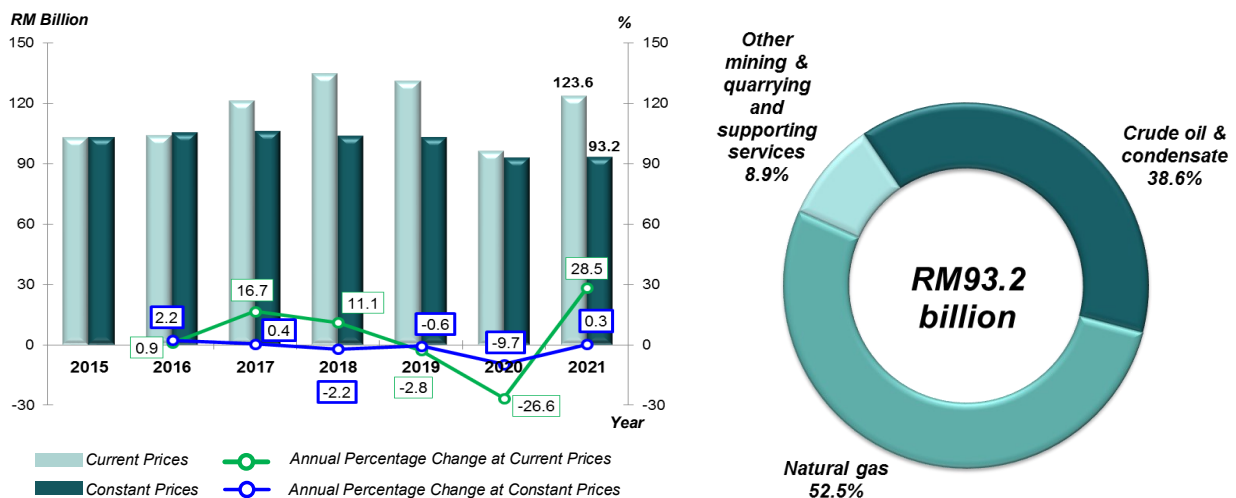
Chart 5 Agriculture - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



MINING AND QUARRYING

The **Mining and quarrying** sector grew 0.3 per cent from a negative 9.7 per cent in 2020, as presented in Chart 6. The expansion was contributed by the Natural gas sub-sector, which bounced to 6.6 per cent (2020: -9.4%). Meanwhile, Crude oil & condensate and Other mining & quarrying and supporting services decreased 6.5 per cent (2020: -9.5%) and 3.1 per cent (2020: -12.6%) respectively.

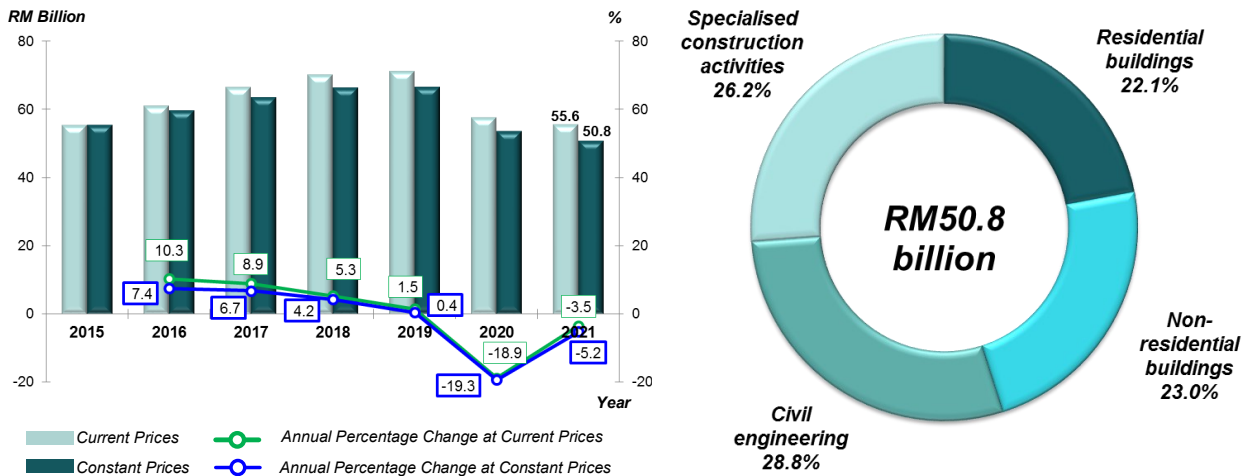
Chart 6 Mining and Quarrying - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices



CONSTRUCTION

The **Construction** sector tumbled 5.2 per cent as compared to a negative 19.3 per cent the preceding year (Chart 7). The contraction was largely attributed to an 18.1 per cent decrease in Civil engineering (2020: -28.1%). Moreover, Residential and Non-residential buildings fell 12.6 per cent (2020: -16.5%) and 2.2 per cent (2020: -15.8%) respectively. Nonetheless, Specialised construction activities accelerated by 20.6 per cent (2020: -8.9%).

Chart 7 Construction - Value Added, Annual Percentage Change and Percentage Share at Constant 2015 Prices

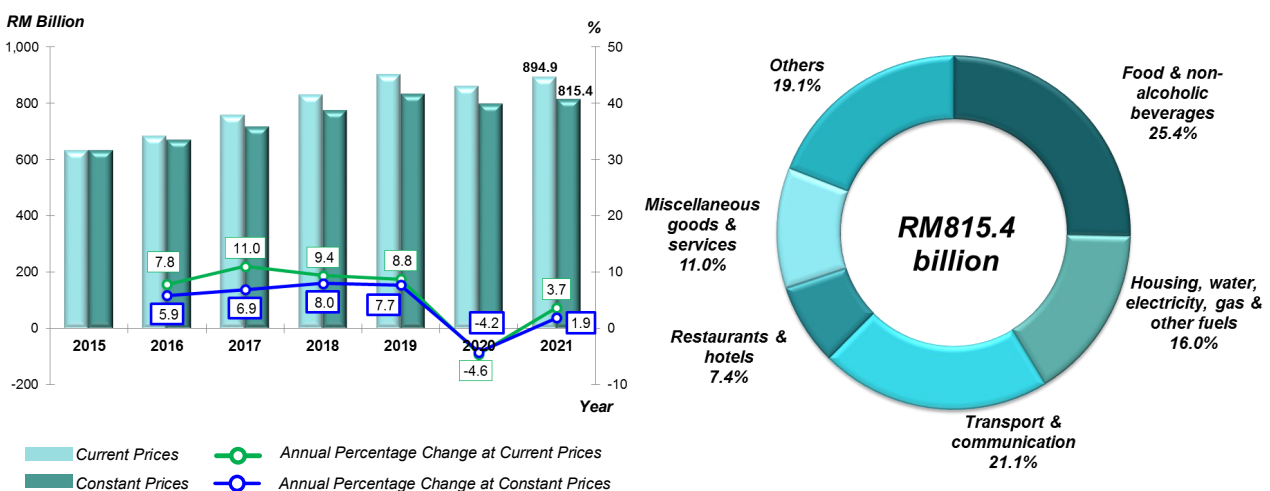


PRIVATE FINAL CONSUMPTION EXPENDITURE

Private final consumption expenditure (PFCE) rose by 1.9 per cent in 2021 after falling by 4.2 per cent the previous year, as shown in Chart 8. The momentum was driven by the consumption of Food & non-alcoholic beverages, Communication and Housing, water, electricity, gas & other fuels.

The share of expenditure on services to total private consumption expenditure slipped from 46.8 per cent in 2020 to 46.0 per cent. Meanwhile, the share of goods expenditure expanded to 54.0 per cent (2020: 53.2%), contributed by non-durable goods (74.1%) and durable goods (15.2 %).

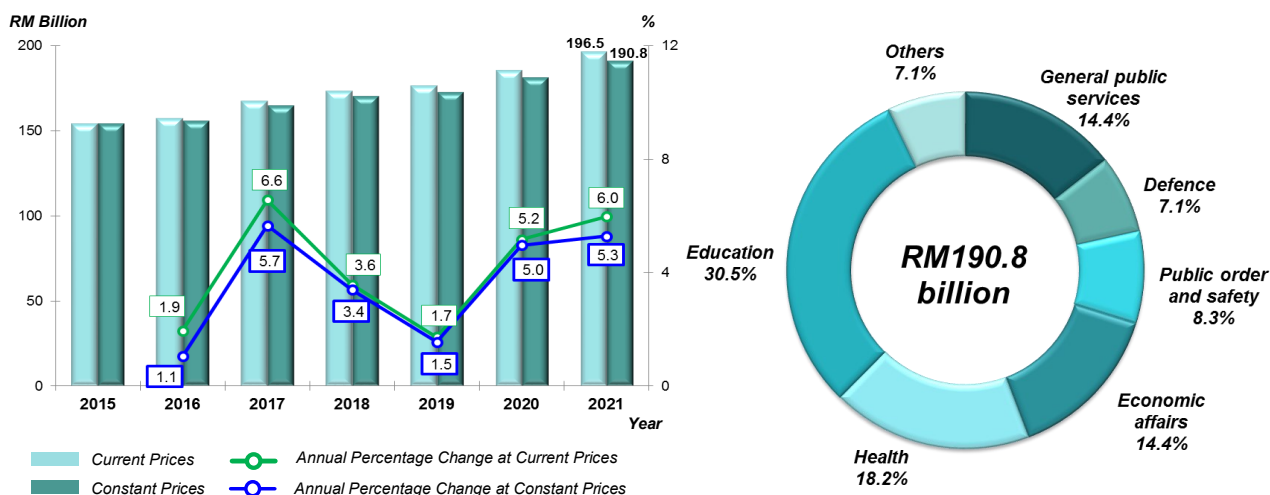
Chart 8 Private Final Consumption Expenditure - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices



GOVERNMENT FINAL CONSUMPTION EXPENDITURE

Government final consumption expenditure (GFCE) expanded to 5.3 per cent from 5.0 per cent a year ago (Chart 9). The growth in expenditure on health, education and housing & community amenities have boosted the overall government spending.

Chart 9 Government Final Consumption Expenditure - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices

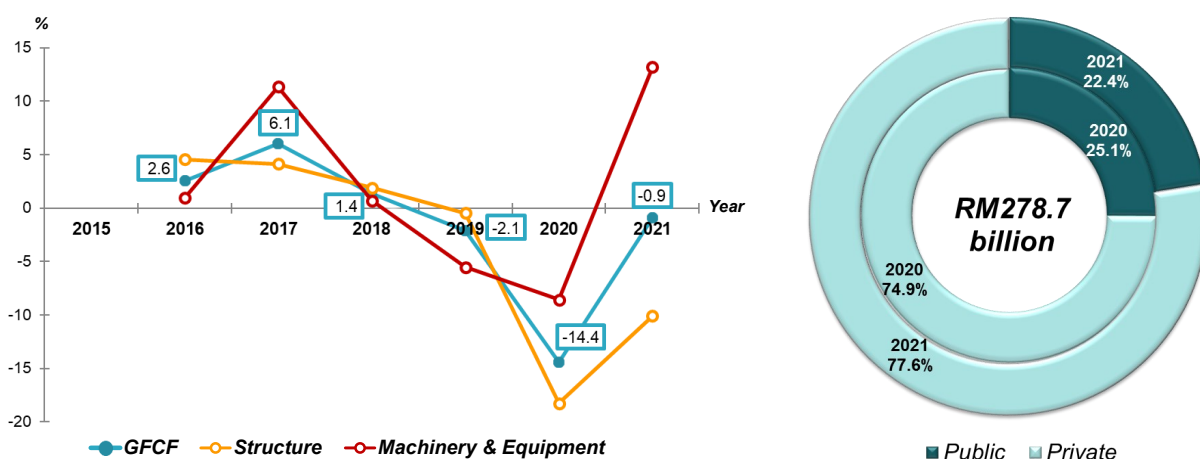


GROSS FIXED CAPITAL FORMATION

Gross fixed capital formation (GFCF) declined marginally by 0.9 per cent from a 14.4 per cent drop the previous year (Chart 10). The slower downturn was influenced by the recovery in Machinery & equipment and Other assets, which elevated to 13.2 per cent and 0.6 per cent respectively. On the contrary, Structure declined 10.1 per cent compared to a negative 18.3 per cent in 2020.

In terms of sector, the Private sector (share: 77.6%) has rebounded to 2.6 per cent from a negative 11.9 per cent in 2020. Nevertheless, the Public sector decreased 11.3 per cent from a contraction of 21.2 per cent the previous year, dragging down the performance of this sector.

EXPORTS AND IMPORTS

Exports surged by 15.4 per cent as compared to a decline of 8.6 per cent in the preceding year (Chart 11). The performance was gassed by Exports of goods, which increased by 18.1 per cent (2020: -0.7%) and accounted for 92.5 per cent of total Exports. Meanwhile, Exports of services contracted 9.6 per cent from a negative 47.8 per cent in 2020.

Imports rose to 17.7 per cent (2020: -7.9%), as depicted in Chart 12. Imports of goods and services both recovered with a growth of 20.5 per cent and 3.2 per cent respectively. Imports of goods accounted for 85.9 per cent of total Imports.

Chart 11 Exports - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices

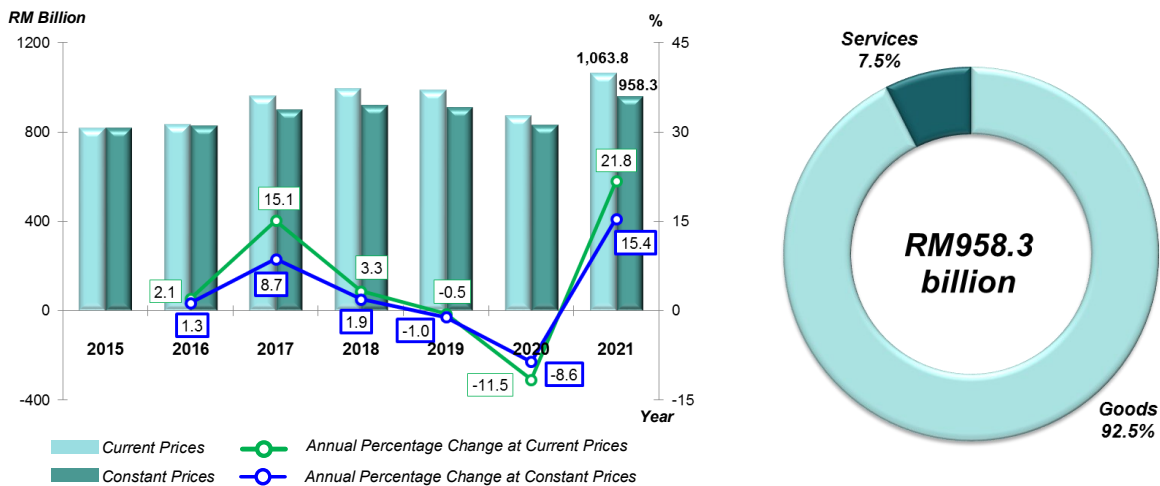
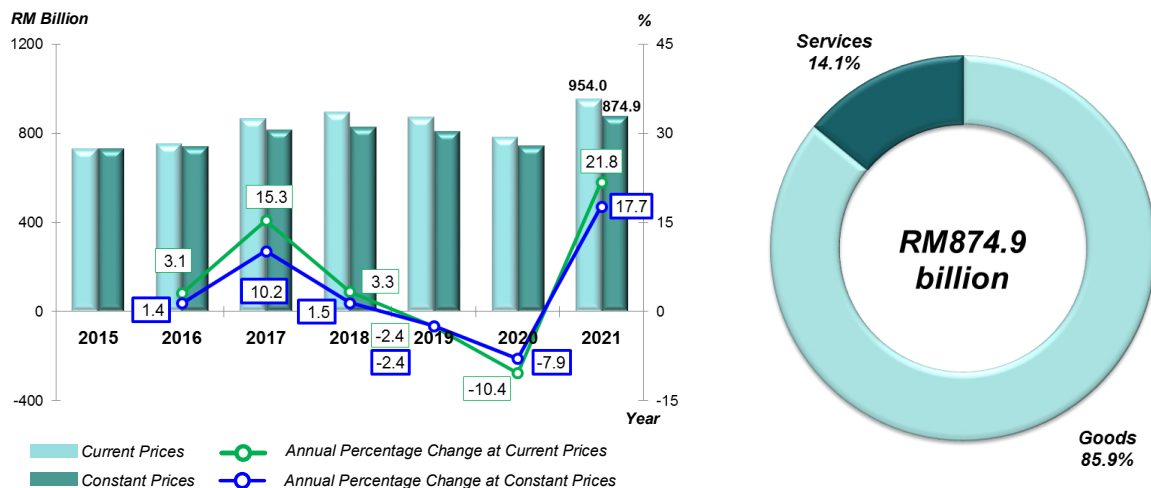


Chart 12 Imports - Value, Annual Percentage Change and Percentage Share at Constant 2015 Prices

KONSEP DAN DEFINISI

PENGENALAN

Penyusunan data akaun negara yang ditunjukkan dalam jadual penerbitan ini adalah item terpilih daripada keseluruhan sistem perakaunan negara yang merekodkan semua aktiviti ekonomi. Sistem perakaunan negara meliputi pengeluaran, perbelanjaan, penjanaaan dan pengagihan pendapatan, pembiayaan, tabungan dan pelaburan bagi keseluruhan ekonomi.

Sistem perakaunan ini ditakrifkan oleh Pertubuhan Bangsa-Bangsa Bersatu dan transaksi yang diberikan adalah mengikut panduan *Systems of National Accounts 2008 (SNA 2008)*.

KELUARAN DALAM NEGERI KASAR (KDNK)

Keluaran Dalam Negeri Kasar (KDNK) adalah jumlah nilai barangan dan perkhidmatan yang dikeluarkan dalam tempoh tertentu selepas ditolak kos barang dan perkhidmatan yang digunakan dalam proses pengeluaran. Nilai ini merupakan nilai sebelum ditolak nilai peruntukan bagi modal tetap; iaitu jumlah nilai ditambah pada harga pengeluar bagi pengeluar residen ditambah dengan duti import. KDNK ini juga bersamaan dengan perbelanjaan ke atas KDNK (pada harga pembeli) iaitu jumlah bagi semua komponen perbelanjaan akhir ke atas barangan dan perkhidmatan tolak dengan import barangan dan perkhidmatan.

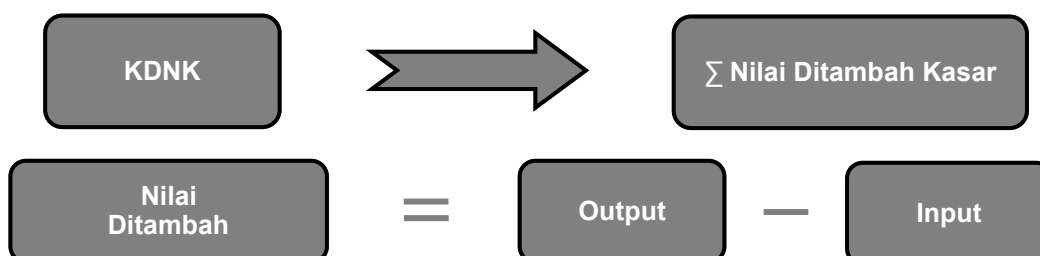
KDNK boleh diukur dengan menggunakan tiga kaedah iaitu Kaedah Pengeluaran, Perbelanjaan dan Pendapatan. Namun begitu, penerbitan ini hanya menggunakan Kaedah Pengeluaran dan Perbelanjaan sahaja.

KAEDAH PENGELUARAN

KDNK berasaskan Kaedah Pengeluaran boleh didefinisikan sebagai jumlah nilai barangan dan perkhidmatan yang dikeluarkan di Malaysia setelah ditolak dengan nilai penggunaan perantaraan. Kaedah ini turut dikenali sebagai kaedah nilai ditambah yang mana ia menunjukkan sumbangan setiap aktiviti ekonomi terhadap keseluruhan KDNK.

KDNK merupakan sistem perakaunan catatan bergu dan dalam penerbitan ini, ianya ditunjukkan seperti berikut:

- (a) Jumlah nilai ditambah kasar bagi semua pengeluar yang terlibat dalam ekonomi; atau
- (b) Perbezaan antara output kasar bagi semua pengeluar tolak penggunaan perantaraan (sebagai input).



OUTPUT

Output adalah nilai barangan dan perkhidmatan yang dikeluarkan. Ini termasuk pengeluaran untuk pasaran, pengeluaran untuk kegunaan sendiri dan pengeluaran bukan pasaran (perkhidmatan kerajaan dan NPISHs). Pengeluaran barangan dan perkhidmatan tidak semestinya untuk dijual atau perolehan oleh pertubuhan.

PENGUNAAN PERANTARAAN

Penggunaan perantara adalah nilai barangan dan perkhidmatan yang digunakan (sebagai input) dalam proses pengeluaran barangan dan perkhidmatan tidak termasuk gaji dan upah, susut nilai daripada modal dan faedah bersih yang dibayar.

NILAI DITAMBAH

Nilai ditambah adalah perbezaan di antara output dan penggunaan perantara. Ia merupakan nilai ditambah barangan dan perkhidmatan dalam aktiviti ekonomi. Oleh itu, ia hampir menyamai dengan keuntungan perniagaan, gaji dan upah, susut nilai dan cukai tidak langsung; campur faedah yang dibayar dan tolak faedah yang diterima.

CUKAI

Di dalam perakaunan negara, cukai dinyatakan dalam dua bentuk iaitu:

(a) CUKAI TIDAK LANGSUNG

Cukai tidak langsung dianggap sebagai kos pengeluaran, di mana ia adalah sebahagian daripada komponen nilai ditambah. Oleh itu, cukai tidak langsung perlu ditambah pada nilai barangan dan perkhidmatan. Cukai tidak langsung termasuk cukai jalan, cukai nilai ditambah, duti eksais, cukai pintu dan lain-lain.

(b) CUKAI LANGSUNG

Cukai langsung adalah cukai ke atas keuntungan dan pendapatan, di mana ia merupakan pengagihan semula pendapatan dari sektor swasta kepada sektor awam dan bukan dalam bentuk kos pengeluaran. Dalam konteks Malaysia, cukai pendapatan merupakan cukai langsung yang paling utama.

KAEDAH PERBELANJAAN

KDNK berasaskan Kaedah Perbelanjaan adalah penjumlahan Penggunaan Akhir Swasta, Penggunaan Akhir Kerajaan, Pembentukan Modal Tetap Kasar, Perubahan Inventori dan Barangan Berharga, Eksport barangan dan perkhidmatan dan ditolak dengan Import barangan dan perkhidmatan. Semua komponen ini dikategorikan sebagai 'permintaan akhir' atau 'perbelanjaan akhir'. Kaedah ini mengira nilai barangan dan perkhidmatan yang digunakan oleh pengguna akhir terhadap barangan dan perkhidmatan yang dikeluarkan oleh residen.

PENGIMBANGAN ANTARA ANGGARAN PENGELUARAN DAN PERBELANJAAN

Secara teori, anggaran KDNK bagi kedua-dua kaedah harus menghasilkan nilai yang sama. Walau bagaimanapun, secara praktikal, anggaran nilai bagi kedua-dua kaedah ini tidak akan sama kerana penggunaan sumber data yang berlainan. Perbezaan ini dikenali sebagai "Perbezaan Statistik" dalam *System of National Accounts*.



PENILAIAN TRANSAKSI

Anggaran dinyatakan dalam dua jenis harga iaitu harga semasa dan harga malar (tahun asas 2015). Pelbagai teknik digunakan dalam membuat nilai anggaran pada harga semasa dan malar.

KDNK PADA HARGA MALAR

KDNK pada harga malar adalah nilai KDNK tanpa kesan harga. KDNK pada harga malar ini penting bagi membolehkan perbandingan sebenar perubahan tingkat pengeluaran/ kuantiti barangan dan perkhidmatan yang berlaku dalam aktiviti ekonomi.

PENDEFLASI HARGA TERSIRAT

Bagi mendapatkan siri harga malar, kaedah deflasi langsung yang terdiri daripada deflasi tunggal dan deflasi berganda digunakan. Kaedah deflasi tunggal menghapuskan pengaruh harga daripada output atau input yang telah dianggarkan manakala deflasi berganda pula menghapuskan pengaruh harga daripada output dan input. Oleh itu, nilai ditambah diperoleh sebagai perbezaan hasil tolak input daripada output.

Indeks harga utama yang digunakan adalah Indeks Harga Pengeluar, Indeks Harga Pengguna dan Indeks Harga Pengeluar Perkhidmatan. Sementara itu, bagi barangan dan perkhidmatan yang tidak terdapat dalam kedua-dua indeks ini, maklumat harga diperoleh dari pertubuhan yang terlibat. Maklumat ini kemudiannya dijadikan indeks harga terbitan khususnya bagi barangan dan perkhidmatan tersebut.

HUBUNGAN ANTARA ANGGARAN KDNK DAN IMBANGAN PEMBAYARAN

Siri akaun negara yang dikeluarkan dalam penerbitan ini adalah konsisten dengan anggaran tahun imbalan pembayaran yang dikeluarkan oleh Jabatan Perangkaan Malaysia. Kedua-dua anggaran ini menunjukkan penyata yang lengkap mengenai transaksi antara Malaysia dengan negara-negara lain pada harga semasa.

Semakan adalah berdasarkan data terkini banci/ survei tahunan/ dwi-tahunan dan akaun syarikat/ perusahaan individu bagi tahun 2019 dan 2020. Bagi tahun terkini 2021, anggaran adalah berdasarkan kepada sumber data suku tahunan.

Siri masa tahunan ini akan dikemaskini setiap tahun.

CONCEPTS AND DEFINITIONS

INTRODUCTION

The national accounts data presented in the tables are selected items from a full national accounting system, which records all economic activities. The national accounting system covers production, expenditure, income generation and distribution, financing, savings and investment of the whole economy.

This accounting system is defined by the United Nations and the transactions which are presented follow the recommendations of the Systems of National Accounts 2008 (2008 SNA).

GROSS DOMESTIC PRODUCT (GDP)

Gross Domestic Product (GDP) is the total value of all goods and services produced in a certain period after deducting the cost of goods and services used up in the process of production. This value is before deducting the allowances for consumption of fixed capital i.e. the sum of value added of resident producer in producer's price plus import duties. GDP is equivalent to expenditure on the GDP (in purchaser's price) i.e. the sum of all components of final expenditure on goods and services less imports of goods and services.

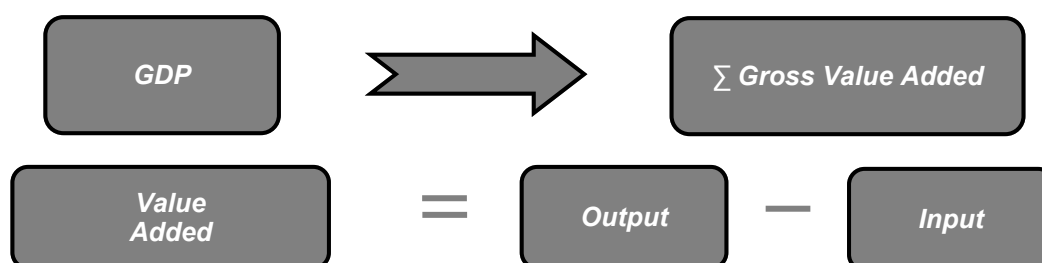
GDP can be measured by using three approaches namely Production, Expenditure and Income Approach. However, this publication only presents Production and Expenditure Approach.

PRODUCTION APPROACH

GDP based on Production Approach is defined as value of total production of goods and services produced in Malaysia after deducting value of intermediate consumption. This approach is also known as value added approach which will be able to show the contribution of each economic activity on overall GDP.

GDP is an item in a double entry accounting system and in this publication, it is presented in the following ways:

- (a) The sum of gross value added of all producers engaged in production in the economy; or
- (b) The difference between gross output of all producers less the intermediate consumption (as input)



OUTPUT

Output is the value of goods and services produced. This includes market production, production for own final use, and non-market production (government services and NPISHs). Production of goods and services is not necessarily for sale or turnover of establishment.

INTERMEDIATE CONSUMPTION

Intermediate consumption is the value of goods and services consumed (as input) in the production process of goods and services excluded salaries and wages, depreciation of capital and net interest paid.

VALUE ADDED

Value added is the difference between output and intermediate consumption. It represents the added value of goods and services by economic activity. Hence, it is approximately equivalent to commercial profit, salaries and wages, depreciation and indirect taxes; plus interest paid less interest received.

TAXES

In national accounts, taxes are expressed in two forms:

(a) **INDIRECT TAXES**

Indirect taxes are regarded as a cost of production, which are part of value added component. Hence, indirect taxes must be added to the value of goods and services. Indirect taxes include sales tax, value added taxes, excise duties, quit rent and etc.

(b) **DIRECT TAXES**

Direct taxes are taxes on profits or incomes, which constitute of a redistribution of income from the private sector to the government and it is not in the form of production cost. In Malaysia's context, income tax is the most significant direct tax.

EXPENDITURE APPROACH

GDP based on Expenditure Approach is the summation of Private Final Consumption, Government Final Consumption, Gross Fixed Capital Formation, Changes in Inventories and Valuables, Exports of goods and services minus Imports of goods and services. All these components are categorised as 'final demand' or 'final expenditure'. This approach measures value of goods and services used by final users on goods and services produced by resident.

BALANCING BETWEEN THE PRODUCTION AND EXPENDITURE ESTIMATES

Theoretically, the estimates GDP for both approaches should arrive at the same value. However, in practice, the estimated value by both approaches will not be equal due to the usage of different data sources. These differences are known as "Statistical Discrepancy" in System of National Accounts .



VALUATION OF TRANSACTIONS

Estimation is expressed in two types of prices namely current prices and constant prices (base year 2015). Various techniques have been used to estimate value at current and constant prices.

GDP AT CONSTANT PRICES

GDP at constant prices is the value of GDP without price effect. GDP at constant prices enables actual comparison to be made for changes in level of production/ volume of goods and services occurred in economic activity.

IMPLICIT PRICE DEFLATOR

In deriving the constant prices series, direct deflation method which consists of single deflation and double deflation is used. The single deflation method removes the price effect from the estimated output or input, while double deflation method eliminates the price effect from both the output and input. Hence, value added is obtained as residual by subtracting input from output.

Main price indices that are being used are Producer Price Index, Consumer Price Index and Services Producer Price Index. Meanwhile, for goods and services which are not in both indices, information on prices are obtained from establishment involved. The information is then transformed into derived price indices specially for those goods and services.

RELATION BETWEEN GDP ESTIMATES AND BALANCE OF PAYMENT

The national accounts series published in this publication is consistent with the annual estimates of balance of payments published by DOSM. These two estimates show a complete statement of Malaysia transaction with other countries at current prices.
