KATA PENGANTAR

Penerbitan ini memaparkan statistik suku tahunan produktiviti buruh di Malaysia bagi suku tahun keempat 2021. Konsep produktiviti buruh yang digunakan merujuk kepada nisbah di antara nilai ditambah dan input iaitu jam bekerja dan pekerja. Statistik yang diterbitkan adalah berdasarkan saranan daripada *System of National Accounts 2008*, *The United Nations* dan *The Organisation for Economic Co-operation and Development Manual: Measuring Productivity*.

Data suku tahunan yang dibentangkan dalam penerbitan ini bermula dari suku tahun pertama 2017 hingga suku tahun keempat 2021. Anggaran nilai ditambah pada harga malar dinilai pada harga asas 2015 selaras dengan pengasasan semula Statistik Akaun Negara.

Statistik ini disusun mengikut aktiviti ekonomi bagi memenuhi keperluan *Malaysia Productivity Blueprint*. Maklumat yang dihasilkan boleh dijadikan petunjuk utama dalam mengukur produktiviti negara bagi pembentukan, pelaksanaan dan pemantauan polisi serta prestasi ekonomi. Statistik ini juga menjadi rujukan penyelidik, ahli akademik, pihak swasta dan individu.

Terdapat tiga bahagian di dalam penerbitan ini. Bahagian pertama memaparkan ringkasan penemuan utama statistik produktiviti buruh. Jadual perangkaan terperinci dipaparkan di bahagian kedua. Sementara itu, aspek teknikal seperti skop dan liputan, konsep dan definisi serta pembolehubah utama yang digunakan disediakan di bahagian keempat bagi memudahkan pengguna memahami statistik yang diterbitkan.

PREFACE

This publication presents quarterly labour productivity statistics in Malaysia for the fourth quarter of 2021. The concept of labour productivity used refers to the ratio between value added and input namely hours worked and employment. The statistics published are based on the recommendations of the System of National Accounts 2008, The United Nations and The Organisation for Economic Co-operation and Development Manual: Measuring Productivity.

Quarterly data presented in this publication commences from the first quarter of 2017 to the fourth quarter of 2021. The value added estimates in constant prices are expressed in 2015 prices in tandem with the rebasing of National Accounts Statistics.

The information is produced by economic activity to fulfil the requirements of the Malaysia Productivity Blueprint. The statistics provided can be used as an important indicator in measuring national productivity for the formulation, implementation and monitoring policy as well as performance of the economy. The statistics also serve as an essential reference to analysts, economists, academics, private sectors and individuals.

This publication is divided into three sections. The first section presents the summary of findings of the statistics on labour productivity. The second section of this publication provides detailed statistical tables. Meanwhile, technical aspects such as scope and coverage, concepts and definitions as well as key variables used are described in the fourth section to facilitate users in better understanding of the statistics.

The Department of Statistics, Malaysia gratefully acknowledges all parties involved in the success of this publication. All comments and suggestions towards improving this publication in the future are greatly appreciated.




















LABOUR PRODUCTIVITY, VALUE ADDED PER EMPLOYMENT

The performance of labour productivity per employment for the year 2021 rose by 1.8% to record value added per employment of RM90,647 per person




Manufacturing and Services sectors increased while other sectors recorded a decline in labour productivity per employment




LABOUR PRODUCTIVITY , VALUE ADDED PER HOUR WORKED


Value added per hour worked declined by 2.6% with a value of RM41.0 per hour




Produktiviti buruh Malaysia yang diukur sebagai nilai ditambah per jam bekerja mencatatkan peningkatan dengan pertumbuhan 1.3 peratus pada suku keempat 2021 selepas merekodkan penurunan marginal 0.6 peratus pada suku tahun sebelumnya seperti yang digambarkan pada **Carta 1**. Pada suku ini, ekonomi Malaysia melonjak 3.6 peratus (ST3 2021: -4.5%) dengan jumlah jam bekerja meningkat 2.3 peratus (ST3 2021:-3.9%).

Sementara itu, produktiviti buruh yang digambarkan sebagai nisbah nilai ditambah per pekerja pada **ST4 2021** meningkat 1.7 peratus berbanding negatif 5.6 peratus pada ST3 2021. Pekerja meningkat 1.8 peratus (ST3 2021: 1.2%) seperti yang ditunjukkan dalam **Carta 2**.

Dari segi nilai produktiviti buruh, nilai ditambah per jam bekerja ialah RM42.2 per jam pada ST4 2021 (ST3 2021: RM40.9 per jam) manakala nilai ditambah per pekerja adalah RM24,006 per pekerja (ST3 2021: RM21,983 per pekerja).

Secara keseluruhan bagi tahun 2021, produktiviti buruh Malaysia mengikut nilai ditambah per jam bekerja menurun **2.6 peratus** (2020: 3.4%) dengan nilai RM41.0 per jam (2020: RM42.0 per jam). Sebaliknya, produktiviti buruh yang diukur sebagai nilai ditambah per pekerja meningkat **1.8 peratus** (2020: -5.5%) dengan nilai ditambah per pekerja adalah RM90,647 per pekerja (2020: RM89,022 per pekerja).

PERTANIAN


Pada suku ini, pertumbuhan produktiviti buruh dari segi nilai ditambah per jam bekerja bagi sektor Pertanian pulih kepada **1.7 peratus** (ST3 2021:-3.4%) seperti yang digambarkan pada Paparan 1. Nilai ditambah dan jam bekerja sektor ini masing-masing berkembang sebanyak 2.8 peratus (ST3 2021: -1.9%) dan 1.1 peratus (ST3 2021: 1.5%).

Sementara itu, produktiviti buruh yang diukur sebagai nisbah nilai ditambah per pekerja meningkat semula **2.9 peratus** berbanding negatif 2.6 peratus pada suku sebelumnya manakala pekerja jatuh 0.1 peratus (ST3 2021: 0.6%).

Dari segi nilai ditambah per jam bekerja bagi sektor ini pada ST4 2021 adalah RM25.4 per jam (ST3 2021: RM27.6 per jam) manakala nilai ditambah per pekerja adalah RM13,498 per pekerja (ST3 2021: RM14,537 per pekerja).

Produktiviti buruh mengikut nilai ditambah per jam bekerja menurun **4.6 peratus** pada 2021 (2020: 1.9%) dengan nilai RM25.1 per jam (2020: RM26.3 per jam) manakala produktiviti buruh per pekerja turun marginal **0.6 peratus** (2020: -1.8%) dengan nilai RM52,939 per pekerja (2020: RM53,254 per pekerja).

PERLOMBONGAN DAN PENGKUARIAN


Produktiviti buruh per jam bekerja bagi sektor Perlombongan dan pengkuarian menguncup **9.3 peratus** berbanding pertumbuhan positif 4.1 peratus pada suku tahun sebelumnya (**Paparan 2**). Pada suku ini, nilai ditambah mencatatkan penurunan yang lebih kecil iaitu 0.9 peratus (ST3 2021: -3.6%) manakala jam bekerja meningkat 9.3 peratus (ST3 2021: -7.3%).

Produktiviti buruh mengikut nilai ditambah per pekerja bagi sektor ini jatuh dua digit sebanyak **10.7 peratus** berbanding negatif 1.3 peratus yang dicatatkan pada suku tahun sebelumnya. Di samping itu, pekerja merekodkan pertumbuhan dua digit sebanyak 11.0 peratus pada suku ini (ST3 2021: -2.3%).

Nilai ditambah per jam bekerja bagi sektor Perlombongan dan pengkuarian adalah **RM526.8 per jam pada ST4 2021** (ST3 2021: RM479.6 per jam) manakala nilai ditambah per pekerja adalah **RM311,151 per pekerja** (ST3 2021: RM276,330 per pekerja).

Pada 2021, produktiviti buruh per jam bekerja terus merosot kepada 3.4 peratus berbanding negatif 1.3 peratus pada tahun sebelumnya dengan nilai RM530.5 per jam (2020: RM549.1 per jam) manakala **produktiviti buruh per pekerja turun marginal sebanyak 0.9 peratus (2020: -8.5%) dengan nilai RM1,235,789 per pekerja (2020: RM1,247,616 per pekerja).**

PEMBUATAN


Pada ST4 2021, **produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja di sektor Pembuatan meningkat 4.6 peratus** (ST3 2021: 2.3%) seperti yang digambarkan pada Paparan 3. Nilai ditambah bagi sektor ini berkembang 9.1 peratus (ST3 2021: -0.8%) manakala jam bekerja naik 4.3 peratus (ST3 2021: -3.0%). Subsektor Produk elektrik, elektronik & optikal (9.8%) mencatatkan pertumbuhan tertinggi produktiviti buruh diikuti oleh subsektor Minuman & produk tembakau (8.6%); Produk mineral bukan logam, logam asas & produk logam yang direka (3.5%); serta Minyak dan lemak daripada sayuran & haiwan dan prosesan makanan (3.5%).

Pertumbuhan **produktiviti buruh per pekerja bagi sektor Pembuatan melonjak 5.3 peratus** (ST3 2021: -3.5%) manakala pekerja meningkat 3.6 peratus (ST3 2021: 2.9%).

Nilai produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja adalah RM58.4 per jam pada ST4 2021 (ST3 2021: RM57.3 per jam) manakala nilai ditambah per pekerja adalah RM34,316 per pekerja (ST3 2021: RM31,356 per pekerja).

Pertumbuhan produktiviti buruh yang digambarkan sebagai nilai ditambah per jam bekerja meningkat 3.1 peratus pada 2021 berbanding 7.0 peratus pada 2020 dengan nilai RM57.0 per jam (2020: RM55.3 per jam). Produktiviti buruh yang diukur sebagai nilai ditambah per pekerja meningkat 6.8 peratus (2020: -2.6%) dengan nilai RM128,836 per pekerja (2020: RM120,675 per pekerja).

PEMBINAAN

Sektor Pembinaan kekal merosot dengan negatif dua digit 11.0 peratus pada ST4 2021 (ST3 2021: -5.7%) bagi produktiviti buruh per jam bekerja seperti dipaparkan pada Paparan 4. Pertumbuhan nilai ditambah bagi sektor ini menguncup 12.2 peratus (ST3 2021: -20.6%) manakala jam bekerja jatuh 1.4 peratus (ST3 2021: -15.7%).

Pada suku ini, **produktiviti buruh mengikut nilai ditambah per pekerja bagi sektor ini kekal merosot sebanyak 11.2 peratus** (ST3 2021: -18.8%) manakala pekerja mencatatkan penurunan kecil iaitu 1.2 peratus berbanding negatif 2.1 peratus pada ST3 2021.

Nilai produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja adalah RM15.5 per jam (ST3 2021: RM16.9 per jam) manakala **nilai ditambah per pekerja adalah RM9,063 per pekerja** (ST3 2021: RM8,597 per pekerja).

Produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja pada 2021 jatuh 8.3 peratus (2020: -5.1%) dengan nilai RM16.5 per jam (2020: RM18.0 per jam) manakala **produktiviti buruh yang diukur sebagai nilai ditambah per pekerja jatuh 4.3 peratus** (2020: -15.7%) dengan nilai RM36,644 per pekerja (2020: RM38,279 per pekerja).

Paparan 4 : Produktiviti Buruh Sektor Pembinaan, ST3 2021 - ST4 2021




PERKHIDMATAN

Produktiviti buruh yang diukur sebagai nilai ditambah per jam bekerja bagi sektor Perkhidmatan meningkat marginal sebanyak 0.7 peratus (ST3 2021: -1.8%) seperti yang digambarkan dalam Paparan 5. Nilai ditambah sektor ini pulih 3.2 peratus (ST3 2021: -4.9%) manakala jam bekerja meningkat 2.5 peratus (ST3 2021: -3.2%). Pada suku ini, pertumbuhan tertinggi produktiviti buruh per jam bekerja dalam sektor Perkhidmatan direkodkan oleh Pengangkutan & penyimpanan (9.4%). Ini diikuti oleh subsektor Maklumat & komunikasi dan Kewangan & insurans yang masing-masing mencatatkan 4.8 peratus dan 3.5 peratus. **Produktiviti buruh per pekerja bagi sektor ini naik 1.0 peratus** (ST3 2021: -6.2%) manakala pekerja meningkat 2.1 peratus (ST3 2021: 1.4%).

Dari segi **nilai produktiviti buruh per jam bekerja pada ST4 2021 bagi sektor Perkhidmatan adalah RM39.8 per jam** (ST3 2021: RM37.7 per jam) manakala **nilai ditambah per pekerja adalah RM22,565 per pekerja** (ST3 2021: RM20,423 per pekerja).

Bagi tahun 2021, produktiviti buruh yang digambarkan sebagai nisbah nilai ditambah kepada jam bekerja bagi sektor Perkhidmatan merekodkan penguncupan 4.2 peratus (2020: 3.2%) dengan nilai RM38.1 per jam (2020: RM39.8 per jam) manakala **produktiviti buruh per pekerja mencatatkan peningkatan marginal 0.5 peratus** (2020: -6.0%) dengan nilai RM84,647 per pekerja (2020: RM84,266 per pekerja).

ST3 2021 - ST4 2021**




LABOUR PRODUCTIVITY PERFORMANCE OF FOURTH QUARTER 2021

Malaysia's Labour Productivity


Malaysia's labour productivity as measured by value added per hour worked posted an increase with a growth of 1.3 per cent in the fourth quarter of 2021 after decreased marginally by 0.6 per cent in the preceding quarter as illustrated in Chart 1. During this quarter, Malaysia's economy turned around to 3.6 per cent (Q3 2021: -4.5%) with total hours worked increased by 2.3 per cent (Q3 2021:-3.9%).

In the meantime, labour productivity expressed as the ratio of value added per employment picked up in Q4 2021 by 1.7 per cent as compared to negative 5.6 per cent in Q3 2021. Employment went up by 1.8 per cent (Q3 2021: 1.2%) as shown in Chart 2.

In terms of labour productivity level, value added per hour worked was RM42.2 per hour in Q4 2021 (Q3 2021: RM40.9 per hour) while value added per employment was RM24,006 per person (Q3 2021: RM21,983 per person).

Overall for 2021, Malaysia's labour productivity by value added per hour worked decreased by 2.6 per cent (2020: 3.4%) with a value of RM41.0 per hour (2020: RM42.0 per hour). On the contrary, labour productivity measured as value added per employment rose 1.8 per cent (2020: -5.5%) with the value added per employment of RM90,647 per person (2020: RM89,022 per person).

AGRICULTURE

In this quarter, the growth of labour productivity in terms of value added per hour worked for Agriculture sector turned around to 1.7 per cent (Q3 2021: -3.4%) as depicted in Exhibit 1. The value added and hours worked of this sector expanded by 2.8 per cent (Q3 2021: -1.9%) and 1.1 per cent (Q3 2021: 1.5%) respectively.

Meanwhile, labour productivity expressed as the ratio of value added per employment rebounded to 2.9 per cent as against negative 2.6 per cent in the preceding quarter while employment declined 0.1 per cent (Q3 2021: 0.6%).

In terms of level, value added per hour worked for this sector was RM25.4 per hour in Q4 2021 (Q3 2021: RM27.6 per hour) while value added per employment was RM13,498 per person (Q3 2021: RM14,537 per person).

Labour productivity by value added per hour worked decreased 4.6 per cent in 2021 (2020: 1.9%) with a level of RM25.1 per hour (2020: RM26.3 per hour) while value added per employment declined marginally by 0.6 per cent (2020: -1.8%) with a level of RM52,939 per person (2020: RM53,254 per person).

MINING AND QUARRYING


Labour productivity by value added per hour worked for Mining and quarrying sector contracted 9.3 per cent as compared to a positive growth of 4.1 per cent in the preceding quarter (Exhibit 2). During this quarter, value added posted a smaller decline of 0.9 per cent (Q3 2021: -3.6%) while hours worked improved to 9.3 per cent (Q3 2021: -7.3%).

Labour productivity by value added per employment for this sector decreased double-digit by 10.7 per cent as against negative 1.3 per cent registered in the previous quarter. In addition, employment recorded a double-digit growth of 11.0 per cent during the quarter (Q3 2021: -2.3%).

Value added per hour worked for Mining and quarrying sector was RM526.8 per hour in Q4 2021 (Q3 2021: RM479.6 per hour) while value added per employment was RM311,151 per person (Q3 2021: RM276,330 per person).

In 2021, labour productivity expressed as value added per hour worked declined further to 3.4 per cent as compared to negative 1.3 per cent in the previous year with a level of RM530.5 per hour (2020: RM549.1 per hour) while value added per employment decreased marginally by 0.9 per cent (2020: -8.5%) with a level of RM1,235,789 per person (2020: RM1,247,616 per person).

MANUFACTURING


In Q4 2021, labour productivity as measured by value added per hour worked in Manufacturing sector improved 4.6 per cent (Q3 2021: 2.3%) as illustrated in Exhibit 3. Value added of this sector accelerated to 9.1 per cent (Q3 2021: -0.8%) while hours worked went up by 4.3 per cent (Q3 2021: -3.0%). Sub-sector of Electrical, electronic & optical products (9.8%) recorded the highest growth of labour productivity followed by Beverages & tobacco products (8.6%); Non-metallic mineral products, basic metal & fabricated metal products (3.5%); and Vegetable and animal oils & fats and food processing (3.5%) sub-sectors.

The growth of labour productivity in terms of value added per employment for Manufacturing sector rebounded to 5.3 per cent (Q3 2021: -3.5%) while employment increased 3.6 per cent (Q3 2021: 2.9%).

Level of labour productivity which measured as value added per hour worked was RM58.4 per hour in Q4 2021 (Q3 2021: RM57.3 per hour) while value added per employment was RM34,316 per person (Q3 2021: RM31,356 per person).

The growth of labour productivity expressed as value added per hour worked increased by 3.1 per cent in 2021 compared to 7.0 per cent in 2020 with a level of RM57.0 per hour (2020: RM55.3 per hour). The labour productivity measured as value added per employment turned around to 6.8 per cent (2020: -2.6%) with a level of RM128,836 per person (2020: RM120,675 per person).

CONSTRUCTION


Construction sector remained sluggish with double-digit negative of 11.0 per cent in Q4 2021 (Q3 2021: -5.7%) for labour productivity by value added per hour worked as shown in **Exhibit 4**. The growth of value added in this sector contracted 12.2 per cent (Q3 2021: -20.6%) while hours worked decreased by 1.4 per cent (Q3 2021: -15.7%).

In this quarter, **labour productivity by value added per employment for this sector remained subdued by 11.2 per cent** (Q3 2021: -18.8%) while employment registering a mild decline of 1.2 per cent as opposed to negative 2.1 per cent in Q3 2021.

Level of labour productivity which measured as value added per hour worked was RM15.5 per hour (Q3 2021: RM16.9 per hour) while value added per employment was RM9,063 per person (Q3 2021: RM8,597 per person).

Labour productivity as measured by value added per hour worked in 2021 dropped by 8.3 per cent (2020: -5.1%) with a level of RM16.5 per hour (2020: RM18.0 per hour) while **labour productivity as measured by value added per employment fell 4.3 per cent** (2020: -15.7%) with a level of RM36,644 per person (2020: RM38,279 per person).

Exhibit 4 : Labour Productivity of Construction Sector, Q3 2021 - Q4 2021




SERVICES

Labour productivity as measured by value added per hour worked for Services sector increased marginally by 0.7 per cent (Q3 2021: -1.8%) as portrayed in Exhibit 5. Value added of this sector turned around to 3.2 per cent (Q3 2021: -4.9%) while hours worked went up by 2.5 per cent (Q3 2021: -3.2%). During this quarter, the highest growth of labour productivity in Services sector was recorded by Transportation & storage (9.4%). This was followed by Information & communication and Finance & insurance sub-sectors which were 4.8 per cent and 3.5 per cent respectively. Measuring **labour productivity per employment for this sector, rose by 1.0 per cent** (Q3 2021: -6.2%) as employment increased 2.1 per cent (Q3 2021: 1.4%).

In terms of labour productivity level, **value added per hour worked in Q4 2021 for Services sector was RM39.8 per hour** (Q3 2021: RM37.7 per hour) while **value added per employment was RM22,565 per person** (Q3 2021: RM20,423 per person).

For the year 2021, labour productivity expressed as the ratio of value added to hours worked in Services sector recorded a contraction of 4.2 per cent (2020: 3.2%) with a level of RM38.1 per hour (2020: RM39.8 per hour) while **value added per employment posted a marginal increase of 0.5 per cent** (2020: -6.0%) with a level of RM84,647 per person (2020: RM84,266 per person).

PENGENALAN

Penerbitan ini membentangkan statistik produktiviti buruh suku tahunan bagi tempoh suku pertama 2017 hingga suku keempat 2021 mengikut jenis aktiviti ekonomi. Statistik ini disusun berdasarkan konsep dan panduan yang digariskan dalam *System of National Accounts 2008*, *United Nations* dan *The Organisation for Economic Co-operation and Development (OECD) Manual: Measuring Productivity*.

Pengukuran produktiviti buruh per jam bekerja memberikan gambaran yang lebih baik berkenaan perkembangan produktiviti di dalam ekonomi berbanding produktiviti buruh per pekerja kerana elemen perbezaan komposisi pekerja sepenuh masa/separuh masa telah dihapuskan.

KONSEP DAN DEFINISI

Konsep produktiviti boleh didefinisikan nisbah output (barang dan perkhidmatan) kepada input (jumlah jam bekerja dan pekerja). Produktiviti boleh diukur dengan pelbagai kaedah mengikut keperluan dan ketersediaan data. Kaedah-kaedah ini boleh diklasifikasikan kepada dua kategori iaitu Produktiviti Faktor Tunggal dan Produktiviti Pelbagai Faktor. *Malaysia Productivity Blueprint* (MPB) telah menggariskan penggunaan input buruh sebagai indikator produktiviti selari dengan keperluan Rancangan Malaysia Kesebelas.

PRODUKTIVITI BURUH

Produktiviti buruh merujuk kepada kecekapan dan keberkesanan setiap pekerja untuk menjana nilai ditambah atau output keseluruhan. Ia dikira menggunakan nisbah nilai ditambah kepada jumlah jam bekerja atau pekerja mengikut sektor di Malaysia. Faktor-faktor lain yang mempengaruhi nilai ditambah seperti aset dan teknologi tidak boleh diukur melalui kaedah ini.

Pengguna disarankan menggunakan data perubahan peratus bagi tujuan analisis. **Nilai produktiviti buruh dalam penerbitan ini adalah bagi rujukan sahaja dan sebarang analisis perbandingan perlu dibuat secara berhati-hati.**



Bagi seseorang yang mempunyai lebih daripada satu pekerjaan, hanya **pekerjaan yang mengambil masa terbanyak** semasa tempoh rujukan dianggap sebagai **pekerjaan utamanya**. Jika masa bekerja bagi tiap-tiap pekerjaan itu sama, maka pekerjaan yang menghasilkan pendapatan tertinggi adalah pekerjaan utamanya. Dalam kes di mana bilangan jam bekerja dan pendapatannya adalah sama bagi setiap pekerjaan, di mana dia **telah bekerja paling lama** dianggap sebagai **pekerjaan utamanya**.

KAEDAH AM PENGANGGARAN PRODUKTIVITI BURUH

Penganggaran produktiviti buruh suku tahunan diukur menggunakan kaedah Produktiviti Faktor Tunggal. Anggaran ini dibuat berdasarkan maklumat nilai ditambah dengan jumlah jam bekerja dan pekerja mengikut industri. Nilai ditambah yang digunakan adalah nilai pada harga malar di mana ia merujuk kepada nilai barang dan perkhidmatan pada harga asas tahun 2015. Sementara itu, jumlah jam bekerja ialah agregat sebenar jam bekerja pada tempoh rujukan bagi pekerja dan bekerja sendiri. Pekerja merujuk kepada keseluruhan pekerja pada tempoh rujukan.

Kaedah penganggaran data pekerja adalah berdasarkan penyesuaian maklumat isi rumah Statistik Tenaga Buruh dan Statistik Guna Tenaga Sektor Informal dan maklumat pertubuhan daripada Perangkaan Pembuatan Bulanan, Statistik Perkhidmatan Suku Tahunan, Statistik Guna Tenaga Suku Tahunan, Banci Ekonomi dan Statistik Ekonomi Tahunan.

Produktiviti buruh diperoleh daripada nisbah di antara nilai ditambah pada harga malar dengan jumlah jam bekerja atau pekerja. Maklumat tambahan berkaitan penganggaran produktiviti buruh boleh diperoleh dari www.dosm.gov.my.

PRODUKTIVITI BURUH, NILAI DITAMBAH PER JAM BEKERJA

Produktiviti buruh per jam bekerja ditakrifkan sebagai nisbah output (barang dan perkhidmatan) kepada input (jumlah jam bekerja). Produktiviti buruh per jumlah jam bekerja mencerminkan jumlah output yang dihasilkan dalam tempoh sejam berdasarkan kategori pekerja sama ada sepenuh masa, separuh masa atau bekerja sendiri. Berdasarkan manual *Measuring Productivity* oleh OECD, pengukuran input produktiviti faktor tunggal yang paling sesuai adalah berdasarkan jumlah jam bekerja.

$$\text{Jumlah jam bekerja} = \text{Purata jam bekerja} \times \text{Pekerja}$$

Purata jam bekerja ditakrifkan sebagai jumlah jam bekerja bagi seorang pekerja. Pekerja merujuk kepada jumlah keseluruhan pekerja pada akhir tempoh rujukan tidak termasuk pekerja yang tidak bekerja semasa tempoh rujukan disebabkan sakit, kecederaan, ketidakupayaan, cuaca buruk, cuti, pertikaian buruh dan sebab sosial/ agama. Jumlah jam bekerja untuk keseluruhan pekerja pada tempoh rujukan ialah agregat jam bekerja sebenar bagi tempoh satu suku tahunan ialah hasil darab pekerja dengan purata jam bekerja seminggu yang kemudianya didarabkan dengan 13 minggu.

PRODUKTIVITI BURUH, NILAI DITAMBAH PER PEKERJA

Produktiviti buruh mengikut pekerja diukur sebagai nisbah output (barang dan perkhidmatan) kepada input (pekerja). Pekerja merujuk kepada semua orang yang bekerja untuk upah atau keuntungan (atau bayaran bukan tunai) dan orang yang tidak hadir bekerja untuk sementara waktu kerana sakit, bersalin, cuti, latihan atau kerana pertikaian buruh; dan pekerja keluarga tanpa gaji yang bekerja sekurang-kurangnya selama satu jam dalam seminggu.

9 SUBSEKTOR KEUTAMAAN

Salah satu strategi nasional untuk memacu pertumbuhan dan perkembangan ekonomi secara berterusan adalah melalui kerjasama industri di Malaysia. Oleh itu, kerajaan telah melancarkan *Malaysia Productivity Blueprint* (MPB) pada Mei 2017 sebagai sebahagian daripada Rancangan Malaysia ke-11. Terdapat 9 subsektor keutamaan yang dikenalpasti melalui MPB juga boleh menunjukkan potensi pertumbuhan yang tinggi untuk negara. 9 subsektor keutamaan mengikut kategori tiga sektor utama ekonomi ialah sektor Perkhidmatan, Pembuatan dan Pertanian.

KONSEP DAN DEFINISI

9 subsektor keutamaan telah dikenal pasti antaranya peruncitan dan makanan & minuman; elektrik dan elektronik; kimia dan produk kimia; agro-makanan; perkhidmatan profesional; pelancongan; teknologi, maklumat dan komunikasi; mesin dan peralatan; dan penjagaan kesihatan swasta. 9 subsektor ini dipilih kerana telah menyumbang 30 peratus kepada Keluaran Dalam Negeri Kasar (KDNK) Malaysia dan 40 peratus kepada jumlah pekerja.

Subsektor ini diberi keutamaan berdasarkan kriteria berikut:

- Jumlah sumbangan kepada KDNK
- Jumlah sumbangan kepada tenaga buruh
- Peluang untuk penambahbaikan produktiviti
- Kesan pengganda yang tinggi
- Ketersediaan untuk melaksanakan penambahbaikan dalam produktiviti

9 subsektor keutamaan untuk memacu pelaksanaan inisiatif produktiviti seperti yang digariskan oleh *Malaysia Productivity Blueprint* (MPB) adalah seperti berikut:



PENERBITAN DAN SEMAKAN STATISTIK

Statistik produktiviti buruh bermula dari suku pertama 2017 hingga suku keempat 2021 disusun berdasarkan anggaran Keluaran Dalam Negeri Kasar, jam bekerja dan pekerja. Statistik pekerja telah diselaraskan berdasarkan data terkini banci dan survei yang dilaksanakan oleh Jabatan. Semakan statistik produktiviti buruh adalah tertakluk kepada semakan statistik nilai ditambah, jam bekerja dan pekerja.

INTRODUCTION

This publication presents the quarterly statistics of labour productivity for the period of the first quarter of 2017 to the fourth quarter of 2021 by economic activity. These statistics are compiled based on the concepts and guidelines outlined in the System of National Accounts 2008, United Nations and The Organisation for Economic Co-operation and Development (OECD) Manual: Measuring Productivity.

Measuring labour productivity per hours worked provides a better picture of productivity developments in the economy against labour productivity per employment, as it eliminates differences in the full time/part time composition of the workers.

CONCEPT AND DEFINITION

The concept of productivity can be defined as output (goods and services) ratio to input (total hours worked and employment). Productivity can be measured by various methods depending on the requirements and availability of data. These methods can be classified into two categories namely Single Factor Productivity and Multifactor Productivity. Malaysia Productivity Blueprint (MPB) has outlined the use of labour input as a productivity indicator in line with the requirement of the Eleventh Malaysia Plan.

LABOUR PRODUCTIVITY

Labour productivity refers to the efficiency and effectiveness of each employee to generate value added or overall output. It is calculated by using the ratio of value added to the total hours worked or employment by sector in Malaysia. Other factors that influenced value added such as assets and technologies cannot be measured through this method.



Labour Productivity per hours worked



The use of the Single Factor Productivity method affect the productivity values where for certain industries it may not refer to the actual amount of production for an employee. Users are advised to use percentage change data for analysis purposes. The labour productivity values in this publication is for reference only and any comparative analysis should be made with caution.



Did not work during the reference week because of illness, injury, disability, bad weather, leave, labour dispute and social or religious reasons but had a job, farmer enterprise or other family enterprise to return to.

Were temporarily laid-off with pay and would definitely be called back to work.

Were employed less than 30 hours during the reference week because of the nature of their work or due to insufficient work and are able and willing to accept additional hours of work. This group is underemployed.

For a person having more than one job, only the job at which he worked for the **longest number of hours** during the reference week is treated as his principal occupation. Should the number of hours worked for each job be the same, then the job with the highest income is the **principal occupation**. In cases where the number of hours worked and the income earned from each job are the same, the job at which he was **working for the longest period of time** is considered as the **principal occupation**.

GENERAL APPROACH OF LABOUR PRODUCTIVITY ESTIMATION

Quarterly labour productivity estimation is measured using the Single Factor Productivity method. This estimates is based on information of value added with total hours worked and total employment by industry. The value added used at constant prices where it refers to the value of goods and services at 2015 prices. Meanwhile, total hours worked are the aggregate number of hours actually worked during the period in employees and self-employment jobs. Total employment refers to the overall number of employees in the reference period.

The methodology of estimating employment data are based on the calibration of household information namely Labour Force Statistics and Informal Sector Workforce Statistics and information of establishment from Monthly Manufacturing Statistics, Quarterly Services Statistics, Quarterly Employment Statistics, Economic Census and Annual Economic Statistics.

Labour productivity is derived from the ratio of the value added at constant prices with the total hours worked and total employment. Additional information regarding labour productivity estimation can be obtained from www.dosm.gov.my.

LABOUR PRODUCTIVITY, VALUE ADDED PER HOUR WORKED

Labour productivity per hour worked is defined as the ratio of output (goods and services) to input (total working hours). Labour productivity by number of working hours reflects the amount of output produced within an hour based on the category of employees either in full time, part time or self-employed. Based on the Measuring Productivity manual by the OECD, the most appropriate single factor productivity input measurement is based on the number of hours worked.

$$\text{Total hours worked} = \text{Average hours worked} \times \text{Employment}$$

Average hours worked is defined as the total number of hours worked divided by the number of people in employment. Employment refers to the overall number of employees at the end of the reference period excluding the employees who did not work during the reference period because of illness, injury, disability, bad weather, leave, labour dispute and social/ religion reason. Total hours worked for all employment during the reference period are the aggregate number of hours actually worked for a quarter which is the result of multiplying employment with the average weekly hours times 13 weeks.

LABOUR PRODUCTIVITY, VALUE ADDED PER EMPLOYMENT

Labour productivity per employment is measured as output (goods and services) per input ratio (employment). Employment included persons who worked for pay or profit (or pay in kind) and persons who were temporarily absent from work due to illness, maternity, holiday, training or labour dispute; and unpaid family workers who worked for at least one hour within a week.

9 PRIORITY SUB-SECTORS

Unlocking greater productivity within industry in Malaysia is one of the national strategies to drive continuous economic growth and expansion. In line with this, the Government launched the Malaysia Productivity Blueprint (MPB) in May 2017 as part of the 11th Malaysia Plan. Within the MPB, 9 priority sub-sectors were identified as presenting high potential growth for the country. The 9 priority sub-sectors are under three main economic sectors namely Services, Manufacturing and Agriculture.

CONCEPT AND DEFINITION

9 priority sub-sectors are identified as retail and food & beverages (F&B); electrical and electronics (E&E); chemicals and chemical products; agro-food; professional services; tourism; information, communication and technology (ICT); machinery and equipment; and private healthcare. Combined, the 9 priority sub-sectors selected contribute 30 per cent of Malaysia's Gross Domestic Product (GDP) and 40 per cent of total employment.

These sub-sectors are prioritised based on the following criteria:

- Contribution to GDP
- Share of workforce
- Opportunity for productivity improvement
- High multiplier effect
- Readiness to implement productivity improvement

9 priority sub-sectors to drive the implementation of productivity initiatives as outlined by the Malaysia Productivity Blueprint (MPB) are as follows:


